

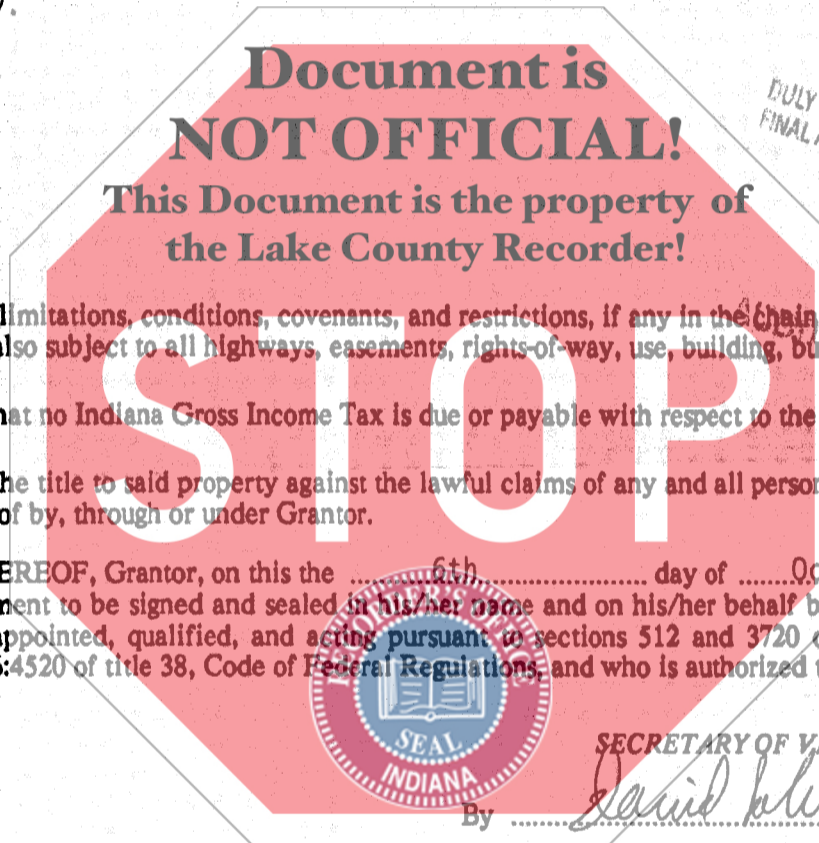
### SPECIAL WARRANTY DEED
