A tract of land situated in the West One-half ($W\frac{1}{2}$) of the Southwest Quarter ($SW\frac{1}{4}$) of Section Twenty-one (21), Township Thirty-eight (38) North, Range Four (4) West, Michigan City, LaPorte County, Indiana, containing three and ninety six thousandths (3.096) acres, more or less, more particularly described as follows:
