

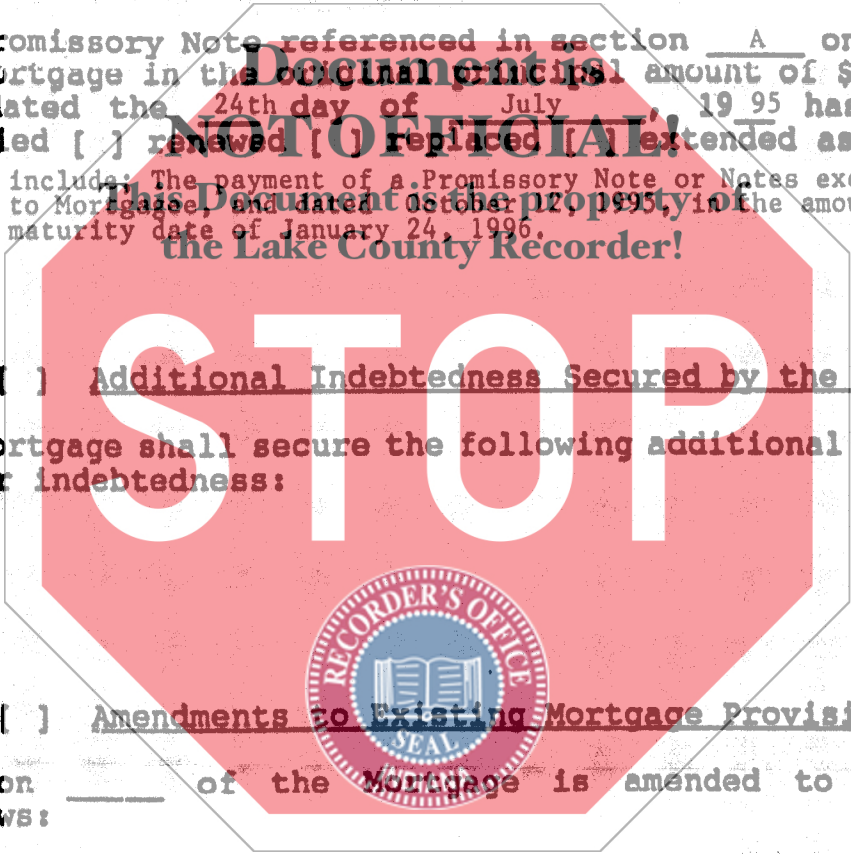
MORTGAGE AMENDMENT AGREEMENT
