WHEREAS, due to notice of this vacation has been given to the public and public hearing has been held in accordance with state law; and

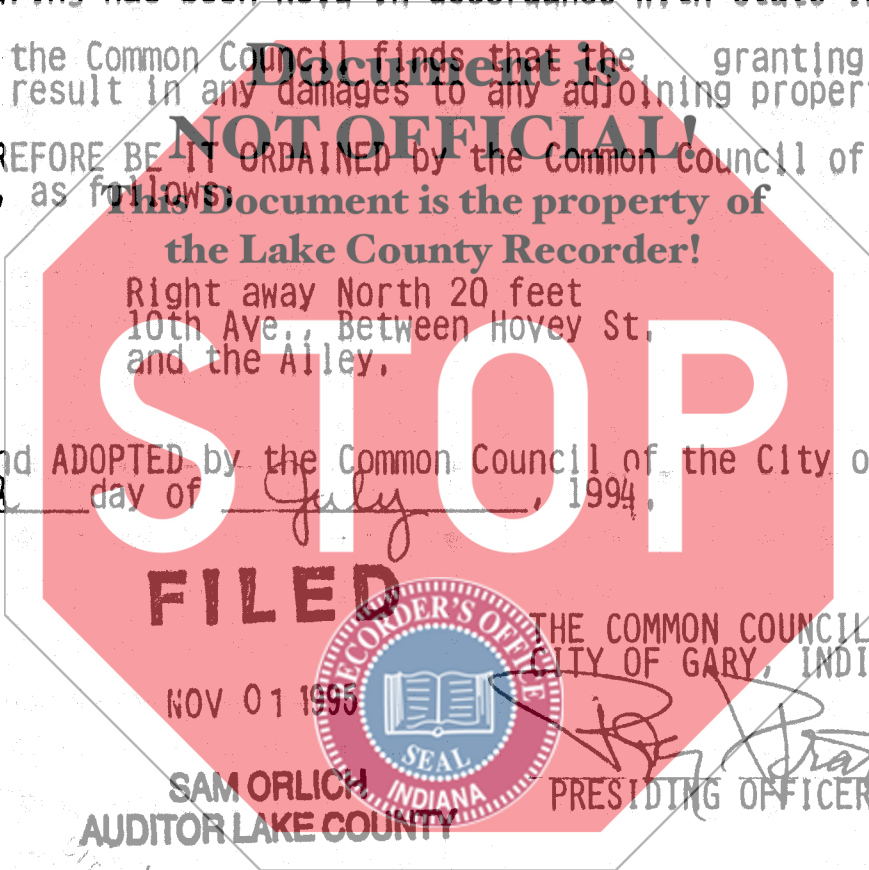
WHEREAS, the Common Council finds that the granting of this vacation will not result in any damages to any adjoining property owner;

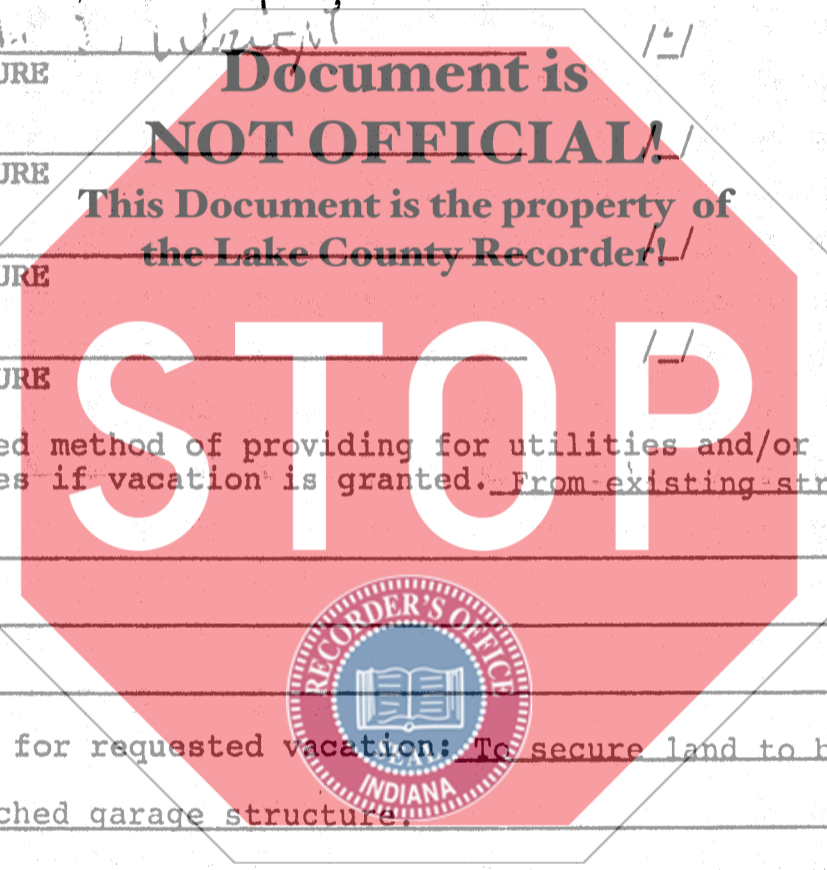

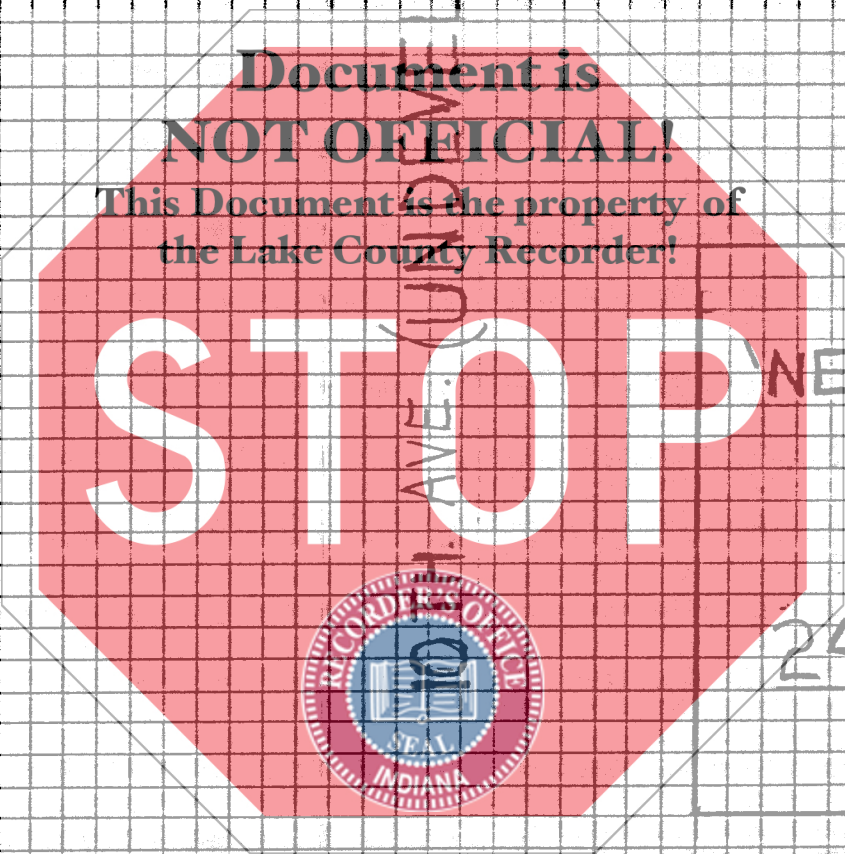

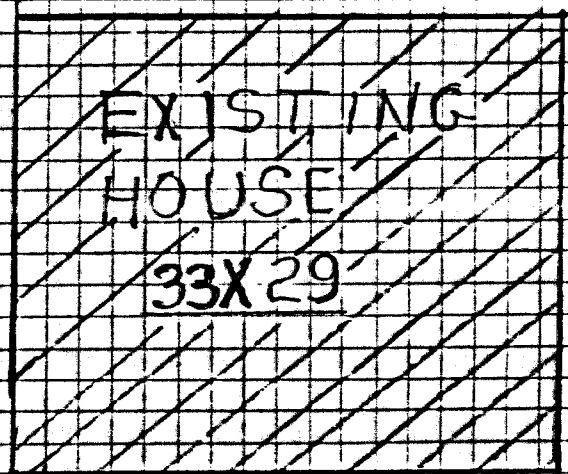
