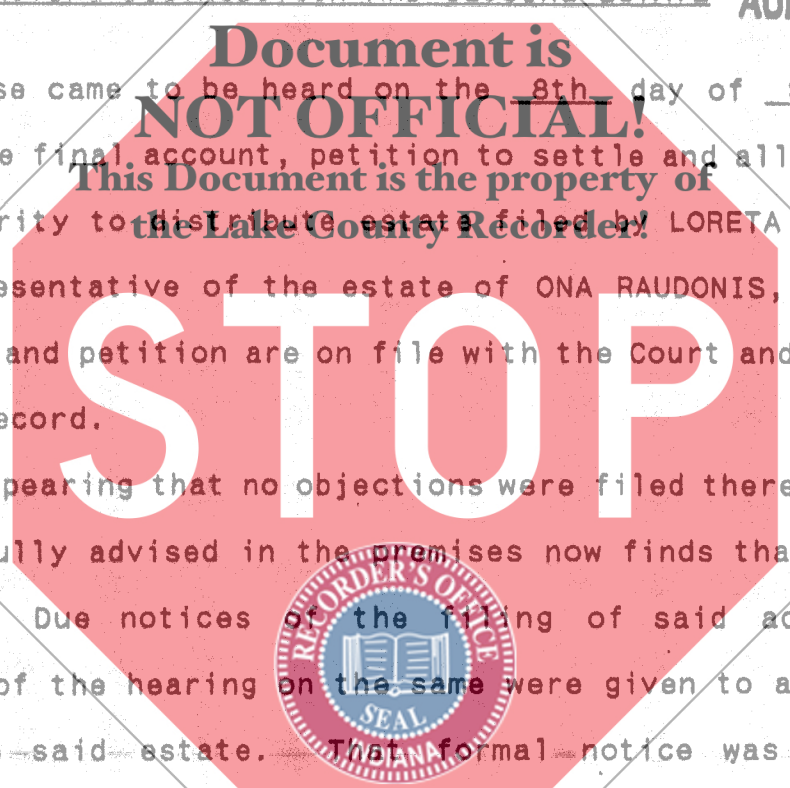

3. That the matters and things stated in said account and petition are true, and that said personal representative has accounted for all the assets in estate coming into her hands.

4. 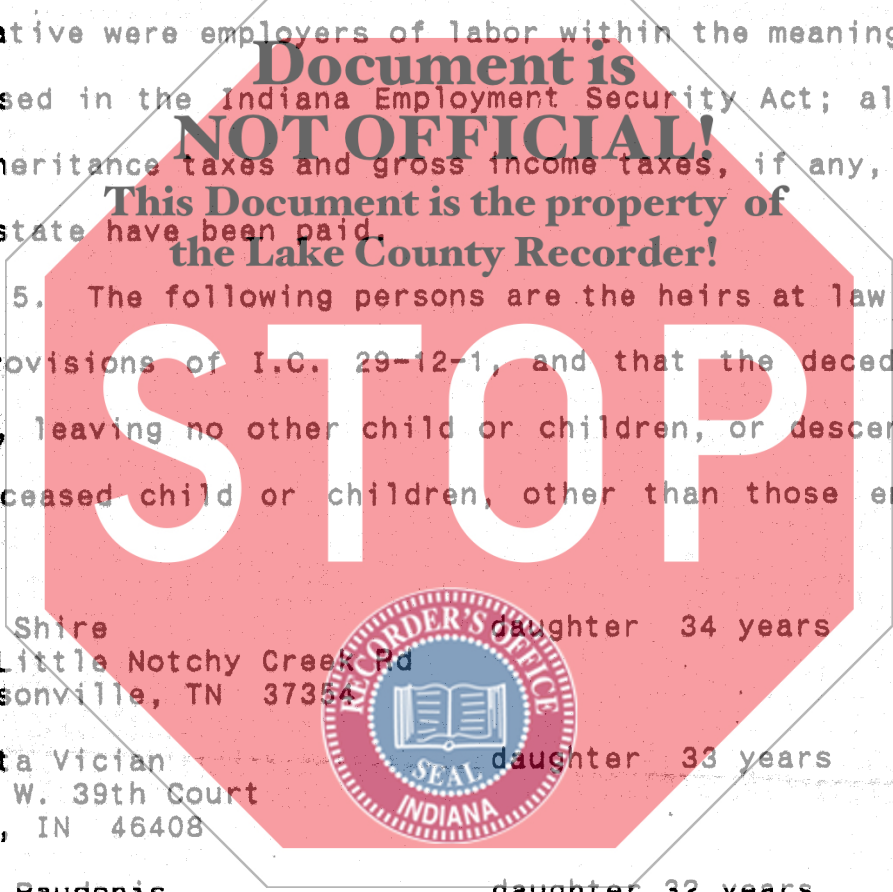

is hereby vested in:


