**ORDER APPROVING EXECUTRIX'S FINAL REPORT  
AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING,  
AND PETITION FOR ORDER APPROVING DISTRIBUTION AND CLOSING ESTATE**

This cause came to be heard on the 6th day of October, 1995, upon the Final Account, Petition to Settle and Allow Account and for Authority to Distribute Estate filed by Beatrice Peterson, Executrix of the Estate of Robert W. Perymun, deceased, which are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the Court being duly advised in the premises now finds that:

1. Due notices of the filing of said Account and Petition and of hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That Robert W. Perymun, died testate, a resident of the County of Lake, State of Indiana, on the 6th day of December, 1993, and his Last Will and Testament was duly admitted to probate before this Court on the 18th day of March, 1994, and this Court appointed said Beatrice Peterson as Executrix of the Last Will and Testament of the Decedent, and said Executrix was issued Letters of Testamentary on the 18th day of March, 1994, to her and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said Account and Petition are true, and that said Executrix has accounted for all the assets in said estate coming into her hands.

4. 
