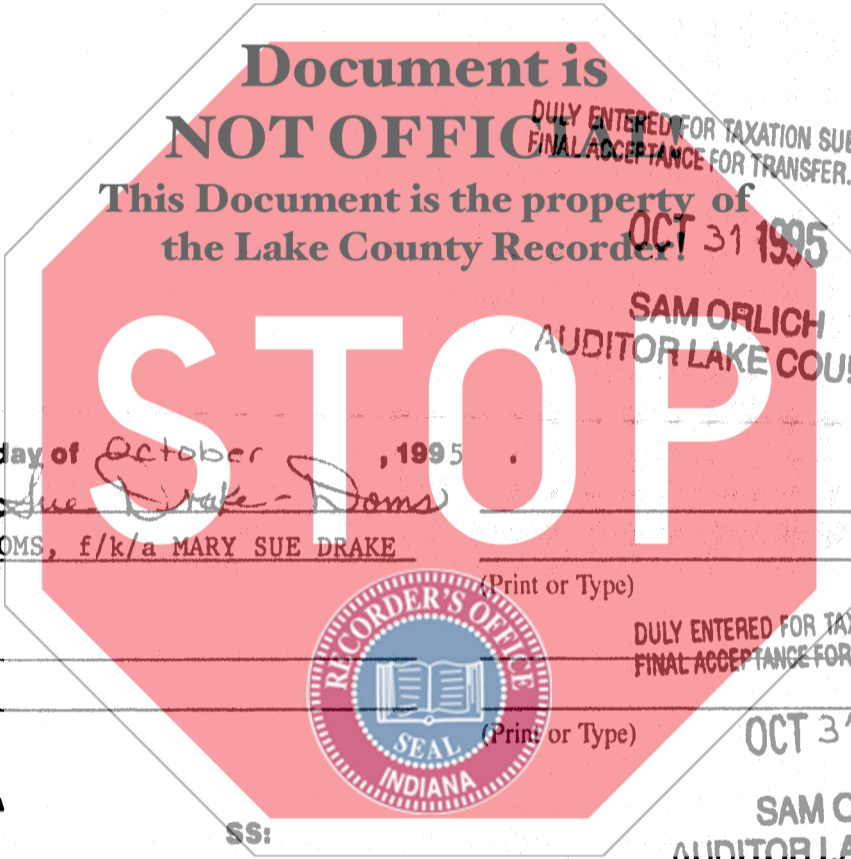
QUITCLAIM DEED
