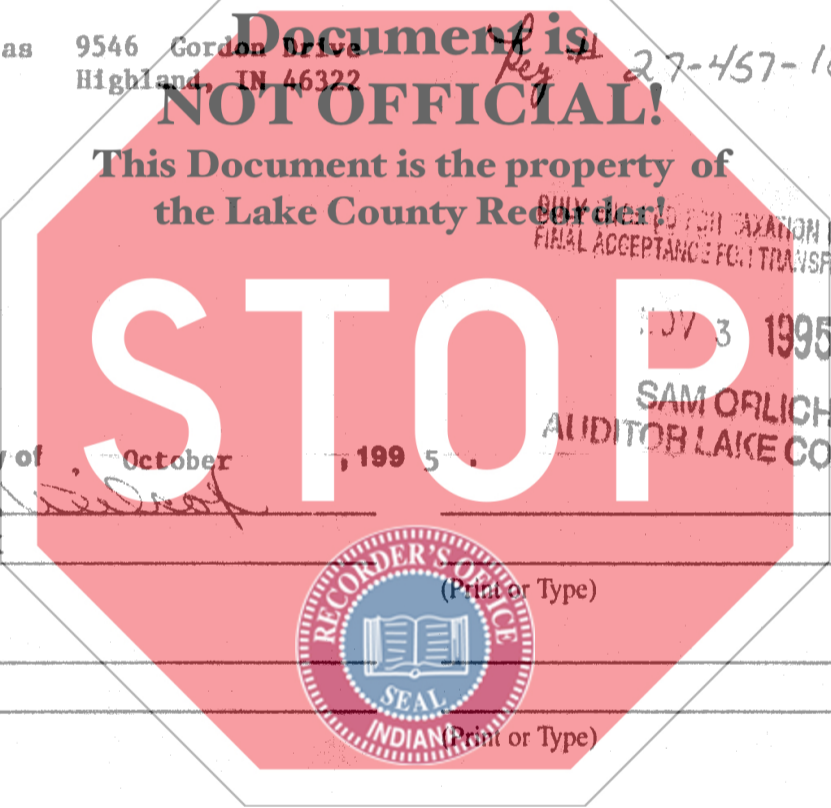
THIS INDENTURE WITNESSETH, that DANA S. WILCOX
