(Monon) Railroad; thence to the centerline of Belshaw Road, thence Southwesterly along the centerline of Belshaw Road a distance of 663.75 feet; thence North along a line which makes an angle of 60°18' with the previous described line, a distance of 400.81 feet; thence East along a line which is at right angle to the previous described line a distance of 349.23 feet, more or less, to the Southwesterly right-of-way line of the C.I. & L.
