ANN V. HANAK TRUST

THIS AGREEMENT, made this 10 day of 1992, between ANN V. HANAK, of Lake County, State of Indiana, hereinafter called the "Grantor" and Olga V. Horvath as "Alternate Trustee".

WITNESSETH:

WHEREAS, the Grantor desires to create a trust containing certain property owned by the Grantor at the present time and property that may be added to or deducted from such trust from time to time for the purpose hereinafter set forth.

WHEREAS the Grantor has herewith assigned transferred, and This Document is the property of conveyed to the Trust Carpus the property described in Schedule "A" annexed hereto in the event that Ann V. Hanak, Grantor is unable, due to disability to act as Trustee, receipt of which is hereby acknowledged by the Trustee, and may cause certain other property and may transfer other property to the Trust, all of which may be designated as the Trust Corpus, which shall be held by the Trustee, in trust for the uses and purposes and upon the terms and conditions herein set forth.

WHEREAS, Grantor, Ana V. Hanax shall act as Trustee for said trust.

WHEREAS, in the event that Ann V. Hanak is unable, due to disability to act as Trustee, the Grantor, Ann V. Hanak does appoint Olga V. Horvath as Alternate Trustee.

WHEREAS, the Trustee shall apply and distribute the income and corpus of the Trust in the following manner and upon the following terms and conditions:

ARTICLE I

The Trustee shall pay on behalf of the Grantor during her life such income and principal as is necessary for her maintenance and well being.

ARTICLE II

A. Upon the death of the Grantor herein, the Trustee shall transfer all of the beneficial interest herein as follows:

To the Holy Trinity Slovak Evangelical Lutheran Church located in East Chicago Istadiana I give One Thousand Dollars (\$1,000.00). If the Holy Trinity Slovak Evangelical Lutheran Church is not exempt from Federal Estate income taxes at the time of my death, or if it is not existent them, in either such event the distribution required baken our recent lapse, and the amount of such distribution shall revert to my estate.

To the Lutheran Retirement Home of Northwest Indiana, the Lutheran Endowment Fund, 1200 East Luther Drive, Crown Point, Indiana I give Five Thousand Dollars (\$5,000.00). If the Lutheran Retirement Home of Northwest Indiana is not exempt from Federal Estate and income taxes at the time of my death, or if it is not in existence, then in either such event, the distribution required by this article shall lapse and the amount of such distribution shall revert to my estate.

To Donna Susan Munt (Flynn) and Dr. Glada Carole Munt I give and bequeath all the contents of my home furnishing. To Donna Susan Munt (Flynn) and Dr. Carole Munt I give and bequeath all my personal jewelry To Olga V. Horvath, Donna Susan Munt (Flynn) and Dr. Glada Carole Munt the balance of beneficial interest of Schedule "A" to be split evenly. If any of these beneficiaries predeceases me, then their share shall lapse to the residue of the trust.

ARTICLE III

A. This Trust may be altered, changed, or amended by the Grantor.

ARTICLE IV

The Trustee shall have the following powers and authority with respect to the trust estate in the event that Ann V. Hanak, Grantor is unable due to disability to act as Trustee and if such Trust is in existence to be exercised for the advantage of the Trust Estate and it's beneficiaries as the Trustee in her discretion shall deem advisable.

- A. To retain any property transferred, devised or bequeathed to the Trustee, regardless diffantifies unproductivity or lack of diversification involved.OFFICIAL!
- B. To invest and reinvest the Trust Estate in any property the Lake County Recorder! whatsoever or undivided interests therein wherever located, including bonds, notes (secured or unsecured), stocks of corporations, real estate or any interest therein and interest in trust, including common trust funds, without being limited by any statute or rule of law regarding investments by Trustee.
- c. To sell any property for cash or upon credit, at public or private sale, or exchange any property for other property and to determine the prices and terms of such sale and exchanges.
 - D. To acquire as assets of the Trust, endowment or annuity

ARTICLE V

The Trustee hereunder shall give to any beneficiary upon her written request, but not more often than annually, a complete statement as to the nature and the amount of the Trust Property, and a statement of income and corpus. The Trustee shall be entitled, at any time, to have a judicial settlement of their account.

ARTICLE VI

My disability shall be deemed during any period when, in the opinion of two (2) licensed physicians, I am incapacitated or disabled because of illness, age or any other cause which results in my inability to effectively manage my property or financial affairs.

I shall also be deemed to be disabled for purposes of this agreement upon the determination of a court of competent jurisdiction that I am (incompetent) is capacitated, or otherwise legally unable to refrectively Phanage Amy property or financial affairs. This Document is the property of

During any period of time when I am disabled, my Trustee shall provide for me and for my valid obligations by observing the following procedural guidelines:

My Trustee shall provide as much of the principal and net income of my trust as is necessary or advisable, in its sole and absolute discretion, for my health, support, maintenance, and general welfare.

My Trustee shall provide as much of the principal and net income of my trust as my Trustee, in its sole and absolute discretion, deems advisable for the payment of any of my valid obligations as confirmed by my Trustee.

ARTICLE VII

In the event that the appointed Alternate Trustee is unable or unwilling to serve, or to continue to serve as Trustee, then and in any such event, Donna Munt (Flynn) of 28121 Royal Ascot, Boerne, Texas or Dr. Glada Carole Munt of 28 Wilderness Way, Roundrock,

Texas (whichever is available) shall be Trustee hereunder in the place and stead of Olga V. Horvath

ARTICLE VIII

The Trustee shall be entitled to the payment of all her expenses hereunder and to reasonable compensation for her services as Trustee.

ARTICLE IX

I instruct my Trustee to maintain any membership of mine in the church with which I compatible deal Suring my lifetime.

Should any provisions of this Trust Agreement be declared invalid provision so as not to defeat the Trust. It is the intent of the Grantor to have this Trust stand as evidencing her intention and the invalidity of one (1) provision should not make the entire Trust Agreement invalid.

ARTICLE X

This Trust Agreement shall extend to and be binding upon the Executor, Administrators and assigns of the Grantor and upon the Successors of the Trustee.

ARTICLE XI

In the event that Ann V. Hanak is unable, due to disability to act as Trustee, the alternate, Olga V. Horvath, shall be responsible to oversee the filing of any income tax returns or other tax reports or schedules.
