

LEGAL DESCRIPTION

Parcel (1) No. 908: Part of the Northwest quarter of the Southwest quarter of Section 9, Township 34 North, Range 8 West of the 2nd Principal Meridian, described as follows: Beginning at a point 190 feet South and 298.80 feet East of the Northwest corner of the Northwest Quarter of the Southwest quarter of said Section 9; thence West and parallel with the North line of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 65 feet; thence Southwesterly to a point 335 feet South and 96 feet East of the Northwest corner of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 194.05 feet; thence South and parallel with the West line of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 38 feet; thence West and parallel with the North line of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 96 feet to a point on the West line of the Northwest quarter of the Southwest quarter of said Section 9 and 373 feet South of the Northwest corner thereof; thence South along the West line of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 12 feet; thence East and parallel with the North line of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 298.8 feet; thence North and parallel with the West line of the Northwest quarter of the Southwest quarter of said Section 9 a distance of 18 feet to the point of commencement, all in the City of Crown Point, Lake County, Indiana.
