**AFFIDAVIT OF SURVIVORSHIP**

Comes now Jerry Z. Razumich, as Personal Representative of the Estate of Goldie Razumich, being duly sworn upon his oath and states as follows:

1. That Goldie Razumich was at the time of her death, the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

Lot Six (6) and the North one-half (1/2) of Lot Seven (7), Block 14, Subdivision of Blocks 1, 2 and 4, Glen Park, as marked and laid down in Plat book 3, page 91, in the Office of the Recorder of Lake County, Indiana, commonly known as 4123 Washington Street, Gary, Indiana.

And that Goldie Razumich and Joe Razumich, now deceased, acquired title, as joint tenants with right of survivorship, to said real estate, by deed of conveyance on the 11th day of August, 1972, and recorded in the Office of the Lake County Recorder.

That Goldie Razumich and Joe Razumich held joint title to said real estate until the death of Joe Razumich, on the 29th of August, 1995, at which time Goldie Razumich acquired title to the real estate as surviving joint tenant.

That the gross value of the estate of the decedent, Joe Razumich, as determined for the purpose of Federal Estate Taxes was less than the value required for the filing of a Federal Estate Tax Return. As a consequence thereof, the decedent's estate was not subject to Federal Estate tax.

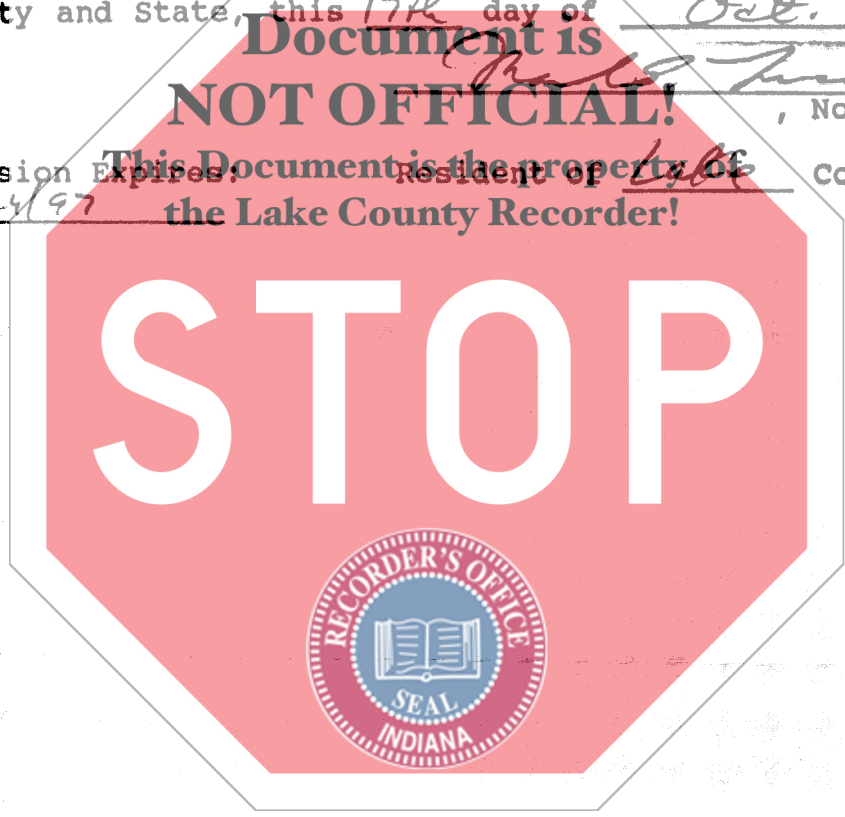
