THIS INDENTURE WITNESSETH: That Northern Indiana Public Service Company, an Indiana corporation, the holder of an easement for electrical lines executed by Francis Dickey, a widow dated August 6, 1942, recorded August 11, 1942, in Book 346, Page 272, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to Francis Dickey and to her successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines, in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A ten (10) foot strip across Lot 28 Block 9 of Highgrove Subdivision, a subdivision in said Section 23, as recorded in the Plat Record 15, Page 21 in the Recorder's Office of Lake County, Indiana; said ten (10) foot strip lying West of and adjacent to a line two and five tenths (2.5) feet West of and parallel to the East line of said Lot 28.

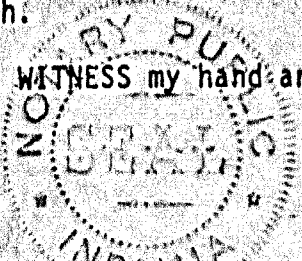
