

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, Sandra E. Any act or thing lawfully done by my Attorney-in-Fact under this instrument shall be binding on the undersigned's assigns, heirs, legatees and devisees, and personal representatives. I hereby give and grant unto said Attorney-in-Fact full power to do every act necessary to be done about the premises as fully as I might or could do if personally presents, with full power of substitution and relocation, hereby ratifying and confirming all that said Attorney-in-Fact or his substitute shall lawfully or cause to be done by virtue thereof.
