taxation purposes as a part of Lot 2, Orkney Square, in Munster, Indiana.

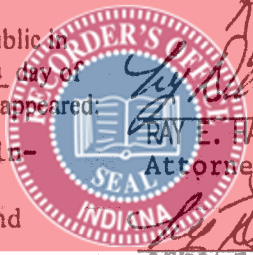
