Lot 17, Block 6, L.R. Williams' Second Addition to Schneider, as shown in Plat Book 9, Page 32, in Lake County, Indiana.

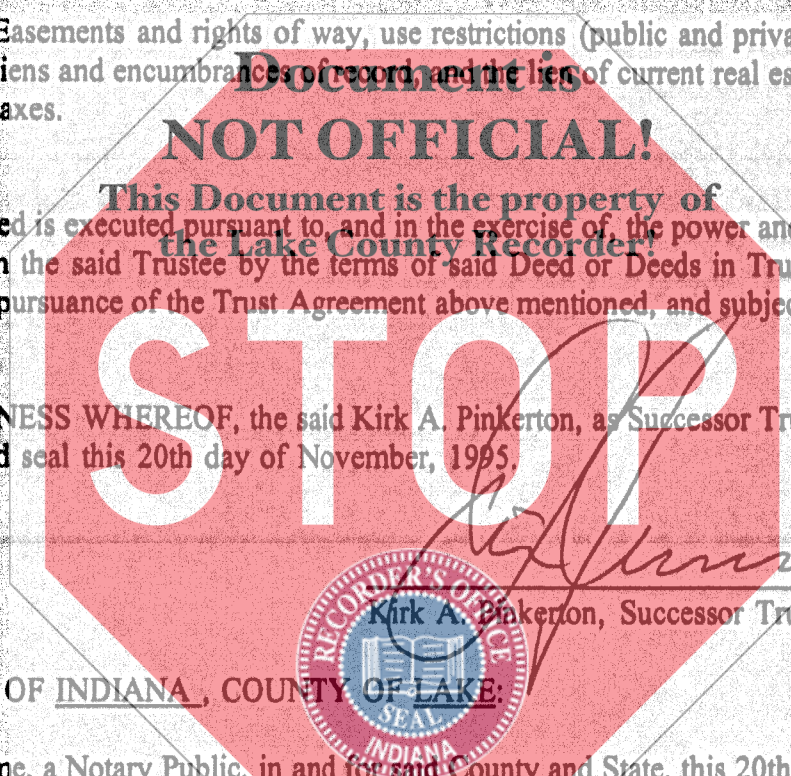

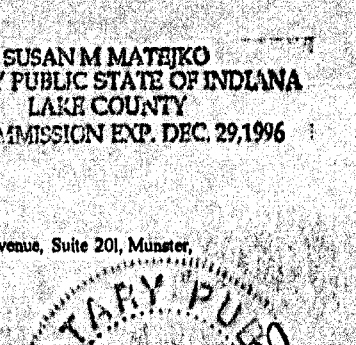
