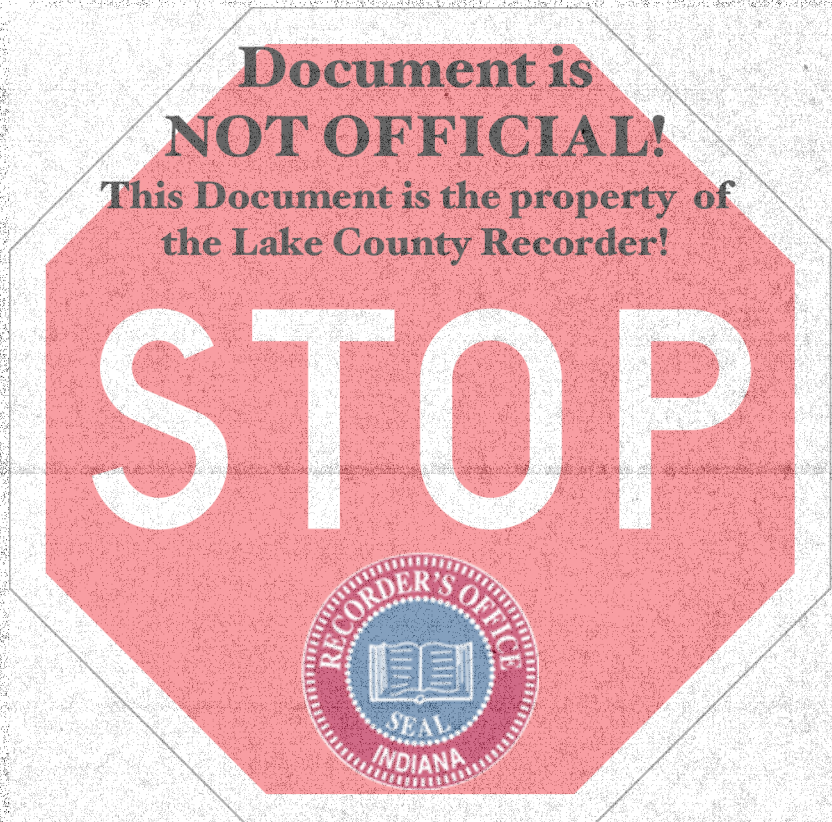
Power of Attorney

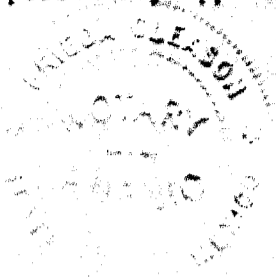
