# DEED OF ASSIGNMENT AND ASSIGNMENT OF REAL ESTATE MORTGAGE

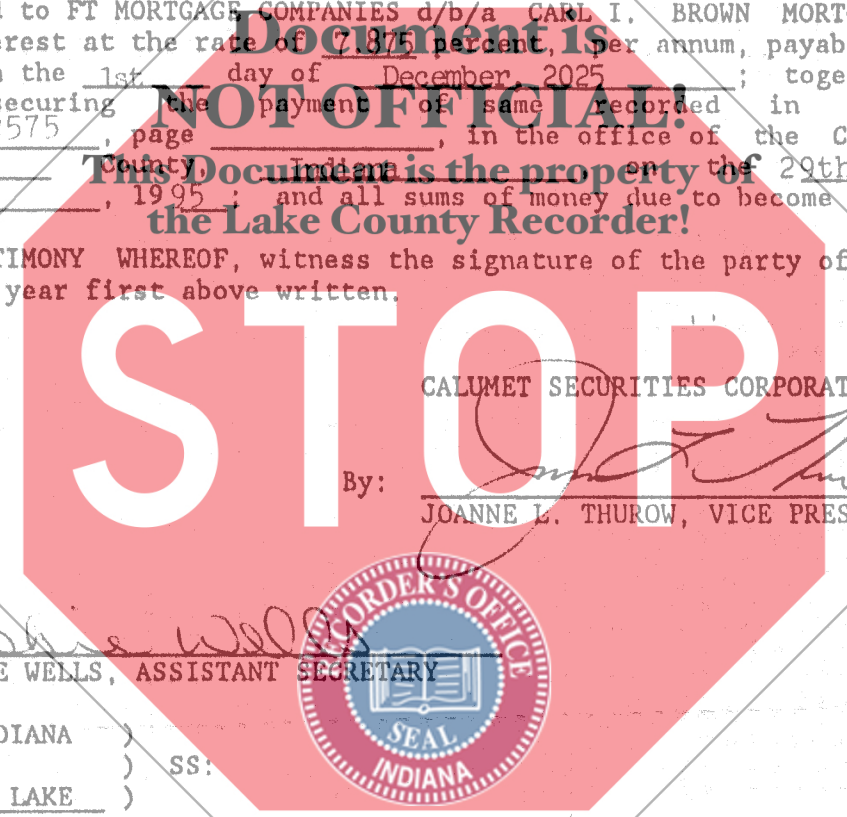
