

LEGAL DESCRIPTION

That part of Lot 4 in Whispering Oaks addition, to the Town of Highland, Lake County, Indiana, described as follows: commencing at the northwest corner of Lot 4: thence north 88 degrees 26 minutes 08 seconds east on the northerly line of said Lot 4 a distance of 79.36 feet to the point of beginning; thence north 88 degrees 26 minutes 08 seconds east on the northerly line of said Lot 4 a distance of 26.05 feet to a point; thence south 06 degrees 23 minutes 00 seconds west a distance of 128.63 feet to the southerly line of said Lot 4; thence westerly on the south line of said Lot 4 said line being on the arc of a circle convex to the southeast having a radius of 394.55 feet and an arc distance of 26.52 feet to a point; thence north 06 degrees 23 minutes 00 seconds east a distance of 131.15 feet to the point of beginning.
