AGREED FINDING AND JUDGMENT

Plaintiff, State of Indiana, by Pamela Carter, Attorney General of Indiana, and

Jeffrey L. Simnick, Deputy Attorney General, and Defendant, Larson's Lumber, Inc., by counsel,

Kathryn D. Schmidt, now jointly move the Court for judgment in this case and in support

whereof make the following representations to the Court.

The Court, having examined the record and being duly advised, now FIN

- 1. Plaintiff filed its Complaint for Appropriation of Real Estate on August
 17, 1995, and all Defendants were served with notice as provided by statute.
- 2. Defendant, Larson's Lumber, Inc., appeared by counsel in this case on or about September 7, 1995.
- 3. Defendant, Lake County, Indiana, has not appeared by counsel in this case.
- 4. Plaintiff and Defendant, Larson's Lumber, Inc., agree and consent that Plaintiff's Complaint for Appropriation of Real Estate complies with Indiana eminent domain law; that the Court has jurisdiction over the subject matter of this case and the parties named

herein, that Plaintiff is entitled by law to appropriate the real estate described in rhetorical paragraph IV of Plaintiff's Complaint; and that the real estate that Plaintiff seeks to appropriate and condemn is appropriated and condemned.

5. Plaintiff and Defendant, Larson's Lumber, Inc., agree to Plaintiff's appropriation of the real estate interests as described below and further agree that Defendant, Larson's Lumber, Inc., shall recover, for the real estate acquired by Plaintiff and any and all damages resulting from that acquisition, total just compensation of Seven Thousand One Hundred Dollars (\$7,100.00) and that no other Defendant is entitled to recover any damages due to Plaintiff's acquisition.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that there is no just reason for delay in entry of judgment upon the terms contained herein and that Plaintiff, State of Indiana, now holds fee simple title, including all rights of possession, to those real estate interests described as:

A part of Lot 1 in Block 5 in Hosford's Park, a subdivision in the Northwest Quarter of the Northeast Quarter of Section 32, Township 36 North, Range 8 West, the plat of which subdivision is recorded in Plat Book, page 7, in the Office of the Recorder of Lake County, Indiana, described as follows: Beginning at the northeast corner of said lot; thence South 2 degrees 34 minutes 00 seconds East 26.47 feet along the east line of said lot to the southeast corner of said lot; thence North 48 degrees 09 minutes 29 seconds West 38.39 feet to the North line of said lot; thence North 88 degrees 57 minutes 55 seconds East 27.79 feet along said north line to the point of beginning and containing 368 square feet, more or less.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that Defendant, Larson's Lumber, Inc., shall have and recover, as total just compensation, for the State's appropriation in this case, the amount of Seven Thousand One Hundred Dollars

(\$7,100.00); that the State shall pay to the Clerk of the Court, Seven Thousand One Hundred Dollars (\$7,100.00), for the benefit of Defendant, Larson's Lumber, Inc.; and the Clerk shall, immediately upon receipt of said amount, pay Defendant, Larson's Lumber, Inc., said Seven Thousand One Hundred Dollars (\$7,100.00), in full satisfaction of this judgment and any and all of Defendant's claims in this case.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that Defendant, Lake County, Indiana, shall take nothing in this case.
