- 9. Inspection. Lender or its agent may make reasonable entries upon and inspections of the Property. Lender shall give Borrower notice at the time of or prior to an inspection specifying reasonable cause for the inspection.

MODIFICATIONS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

### A. INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note has an Initial Interest Rate of 7.15 %. The Note interest rate may be increased or decreased on the first day of the month beginning on June 1, 1999 . As and on that day of the month every twelve (12) months thereafter. Each date on which the interest rate may change will be called a "Change Date."

Interest only will be payable monthly on the outstanding principal balance beginning on the first day of the month following the first disbursement of the loan proceeds and continuing on the first day of each month thereafter until the first day of the month thereafter until the first day of the monthly principal and interest payments will remain fixed at the Initial Interest Rate of the day of the first Change Date. Before each Change Date, the Note Holder will calculate the new interest rate by adding 2.50 % to the Current Index. The Current Index figure is the most recent Index figure available at least 30 but not more than 45 days prior to each Change Date. The Note Holder will round the new interest rate to the nearest one-eighth of one percentage point.

The interest rate will not be changed by more than two (2) percentage points on any Change Date. The maximum interest rate ("Ceiling") charged will not be more than 13.15 %. The Note Holder will adjust the new interest rate so that the change in the interest rate will not be more than those limits.

## B. LOAN CHARGES

It could be that the loan secured by the Security Instrument is subject to law which sets maximum loan charges and that law is interpreted so that the interest or other loan charges collected or to be collected in connection with the loan would exceed permitted limits.
