## SURVEYOR'S REPORT

THIS SURVEY IS BASED ON THE RESULTS OF A PREVIOUS SURVEY BY ANTHONY M. GREGORY, DATED FEBRUARY 11, 1991, AND REVISED JUNE 10, 1991, AND RECORDED IN SURVEY RECORD BOOK 1, PAGE 11. THIS IS ALSO BASED ON THE PREMOUS WORK BY PLUMB TUCKETT AND ASSOCIATES (PTA) ASSOCIATED WITH WESTERHOFF ACRES 1ST ADDITION (PLAT BOOK 78, PAGE 94).

AVAILABILITY AND CONDITION OF REFERENCED MONUMENTS: THE ABOVE-MENTIONED GREGORY SURVEY WAS BASED ON A SECTION BREAKDOWN OF SECTION 3. THIS BREAKDOWN WAS BASED ON ONLY THE FOUR SECTION CORNERS, AS LAKE COUNTY SURVEYOR'S OFFICE DOES NOT HAVE RECORDS OF THE QUARTER CORNERS FOR THIS SECTION. ADDITIONALLY, AN IRON SPIKE WAS FOUND AND HELD AS THE SOUTHEAST CORNER OF THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 3 THIS SPIKE FIT OCCUPATION WELL, AND WAS LOCATED 18.3 FEET NORTH OF AND 10.5 FEET EAST OF THE PROPORTIONAL SOUTHEAST CORNER.

A PK NAIL HAD PREVIOUSLY BEEN SET AT THE NORTHEAST CORNER OF THE SUBJECT PARCEL, BUT APPEARS TO HAVE BEEN COVERED WITH ASPHALT. A REBAR HAS BEEN SET IN ITS PLACE.

OTHER MONUMENTS FOUND AND USED FOR THIS SURVEY WERE THOSE SET FOR WESTERHOFF ACRES 1ST ADDITION. UNLESS OTHERWISE STATED ON THE PLAT, FOUND MONUMENTS WERE UNDISTURBED, IN GOOD CONDITION, OF UNKNOWN ORIGIN, AND AT

B. OCCUPATION AND POSSESSION LINES: THE SOUTH AND WEST LINES OF THIS PARCEL WERE ESTABLISHED BY OCCUPATION (SEE PREVIOUSLY MENTIONED GREGORY SURVEY). UNCERTAINTIES OF UP TO 20 FEET (EAST WEST) AND 10.6 FEET (NORTH-SOUTH) RESULT WHEN COMPARING THE LOCATION OF THESE OCCUPATION LINES WITH PROPORTIONAL SECTION BREAKDOWN LINES AND DEED LINES. THE SURVEYOR'S REPORT IN THE PREVIOUSLY MENTIONED GREGORY SURVEY CONTAINS FURTHER

CLARITY OR AMBIGUITY OF RECORD DESCRIPTIONS: AS STATED ABOVE, THE EAST LINE OF THE SUBJECT PARCEL WAS ESTABLISHED BY POSSESSION. THE DESCRIPTION OF THAT LINE IS AMBIGUOUS (THE ADJOINING PARCEL IS DESCRIBED AS THE EAST 1 1/2 ACRES ...). ALSO, THE DESCRIPTION OF THE PARCEL ADJOINING TO THE SOUTH RECITES BEARINGS AND DISTANCES WHICH APPEAR TO RESULT FROM A PROPORTIONAL BREAKDOWN OF SECTION 3 WHICH AGREES WELL WITH THE PROPORTIONAL BREAKDOWN FOR THIS SURVEY. HOWEVER, SINCE THIS SURVEY HOLDS THE POSITION OF THE IRON SPIKE AND FENCE LINE ALONG THE SOUTH LINE, A GAP RESULTS BETWEEN THE SOUTH LINE OF THIS PARCEL (AS SURVEYED) AND THE NORTH LINE OF THE SOUTHERN ADJOINER (PER DEED DESCRIPTION). THIS GAP RANGES FROM 12.7 FEET TO 15.0 FEET. ALSO, THE PROPORTIONAL EAST LINE OF THE PARCEL IS UP TO 10.6 FEET WEST OF THE LINE ESTABLISHED BY OCCUPATION. AGAIN, FURTHER DISCUSSION ON THIS MATTER CAN BE FOUND IN THE SURVEYOR'S REPORT CONTAINED IN THE PREVIOUS GREGORY SURVEY. IT SHOULD BE ADDITIONALLY NOTED THAT THE BEARING BASIS WITHIN THE DESCRIPTION FOR THE SOUTHERN PARCEL DIFFERS FROM THE BEARING BASIS FOR THIS SURVEY.

THEORETICAL UNCERTAINTY (DUE TO RANDOM ERRORS IN MEASUREMENTS): THE SURVEY PERFORMED MET THE REQUIREMENTS OF A CLASS "D SURVEY PER 865 IAC 7. THE ALLOWABLE THEORETICAL UNCERTAINTY, PER THE STANDARDS, IS 1.00 FEET.


