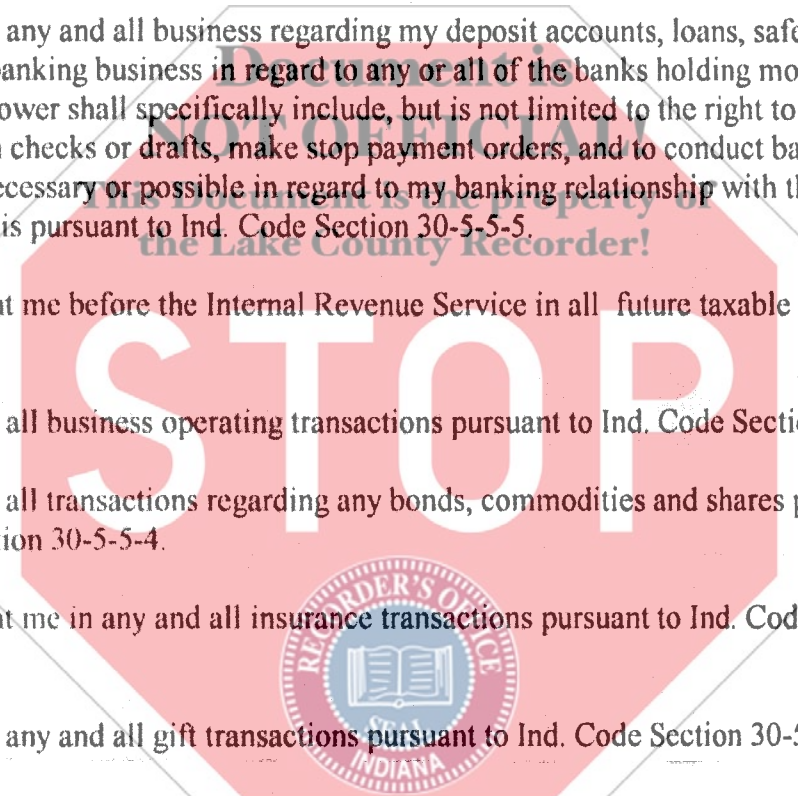

**Durable Power of Attorney**

I, June A. This power shall specifically include, but is not limited to the right to deposit, withdraw, sign checks or drafts, make stop payment orders, and to conduct banking transactions necessary or possible in regard to my banking relationship with the Bank(s); This authority is pursuant to Ind. Code Section 30-5-5-5.
2. To represent me before the Internal Revenue Service in all future taxable years and returns.
3. To conduct all business operating transactions pursuant to Ind. Code Section 30-5-5-6.
4. To conduct all transactions regarding any bonds, commodities and shares pursuant to Ind. Code Section 30-5-5-4.
5. To represent me in any and all insurance transactions pursuant to Ind. Code Section 30-5-5-7.
6. To conduct any and all gift transactions pursuant to Ind. Code Section 30-5-5-9.
7. To represent me in any and all claims and litigation pursuant to Ind. Code Section 30-5-5-11.
8. To have authority with respect to records, reports, and statements pursuant to Ind. Code Section 30-5-5-14.
