RIDER - LEGAL DESCRIPTION

PART OF THE NORTHEAST QUARTER OF SECTION 34 AND PART OF THE SOUTHWEST QUARTER OF SECTION 27, BOTH IN TOWNSHIP 32 NORTH, RANGE 8 WEST OF THE 2ND PRINCIPAL MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEWEST CORNER OF SAID SECTION 34, THENCE SOUTH 0 DEGREES 0 MINUTES EAST ALONG THE WEST LINE OF SECTION 34 A DISTANCE OF 710 FEET, THENCE NORTH 90 DEGREES EAST PERPENDICULAR TO SAID WEST LINE A DISTANCE OF 265 FEET, THENCE NORTH 0 DEGREES 1 MINUTE 50 SECONDS WEST A DISTANCE OF 823.04 FEET, THENCE SOUTH 89 DEGREES 46 MINUTES 30 SECONDS WEST ALONG A LINE THAT IS PERPENDICULAR TO THE WEST LINE OF SECTION 27 A DISTANCE OF 265 FEET TO SAID WEST LINE, THENCE SOUTH ALONG SAID WEST LINE A DISTANCE OF 112 FEET TO THE SOUTHWEST CORNER OF SAID SECTION 27 WHICH IS THE POINT OF BEGINNING, ALL IN LAKE COUNTY, INDIANA.
