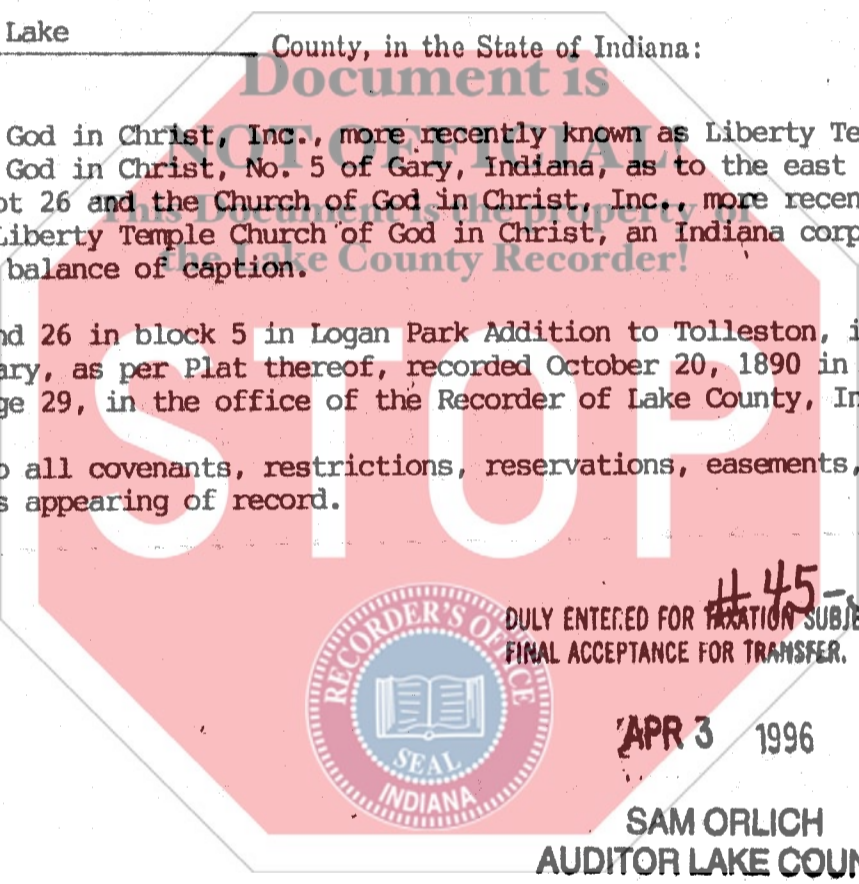
of Lake County, in the State of Indiana, for the sum of Ten Dollars (\$ 10.00) and other

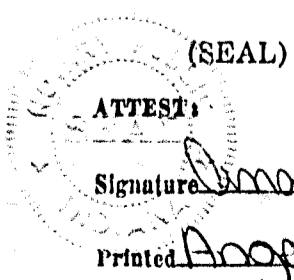
