DURABLE GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, JAMES B. ZABRECKY, as principal, do hereby designate and appoint MARIE L. ZABRECKY, my attorney-in-fact for me, in my name and stead:

- (1) To do, execute and perform any acts, deed, matter or thing whatsoever as my alter ego that ought to be done, executed or performed or that in the opinion of my said attorney ought to be done, executed or performed as fully and effectually as I could do if personally present and/or capable.
- (2) In addition thereto, and without in any way limiting the general power of paragraph (1) hereof, and paragraph (1) hereof not in any way in limitation of the following:
 - (a) To have full power granted pursuant to Indiana Code 30-5-5-1 through 30-5-5-19 inclusive and as amended from time to time, which is incorporated herein by reference as if the same were fully set forth herein.
 - (b) To complete and/or execute any document(s) pertaining to governmental agencies, whether state, federal or foreign. These powers include but are not limited to the completion and execution of documents for any governmental benefit due me, or to purchase or liquidate any governmental investments or securities, such as U.S. Savings Bonds, U. S. Treasury Bills, etc.
- (3) Notwithstanding the powers heretofore provided in this instrument, my said attorney(s) shall not have any power or authority to change, modify, or revoke my last will and testament.
- (4) This Power of Attorney shall not be affected by my subsequent incompetency, disability or incapacity or by the lapse of time since the execution of this instrument.

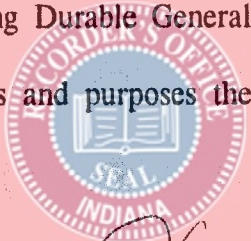

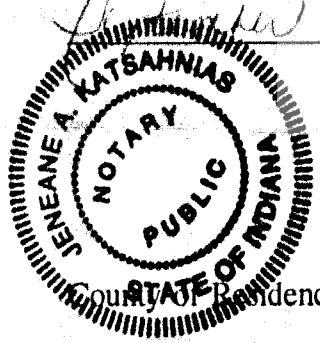
