- (9) any employee of the Corporation who has specific authority delegated to that employee by any of the officers listed in (1) through (7) above or by any committee established pursuant to the bylaws or these rules and regulations.

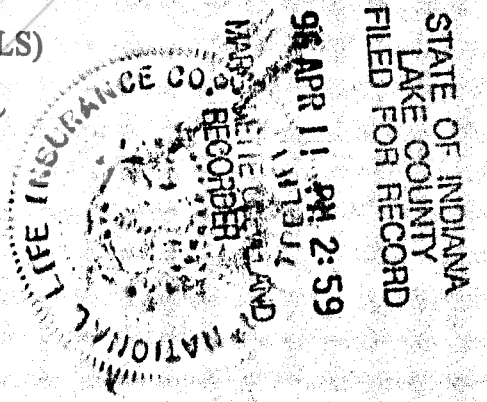

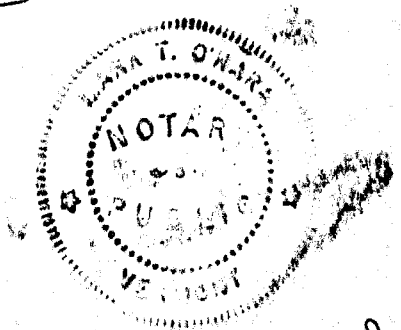
