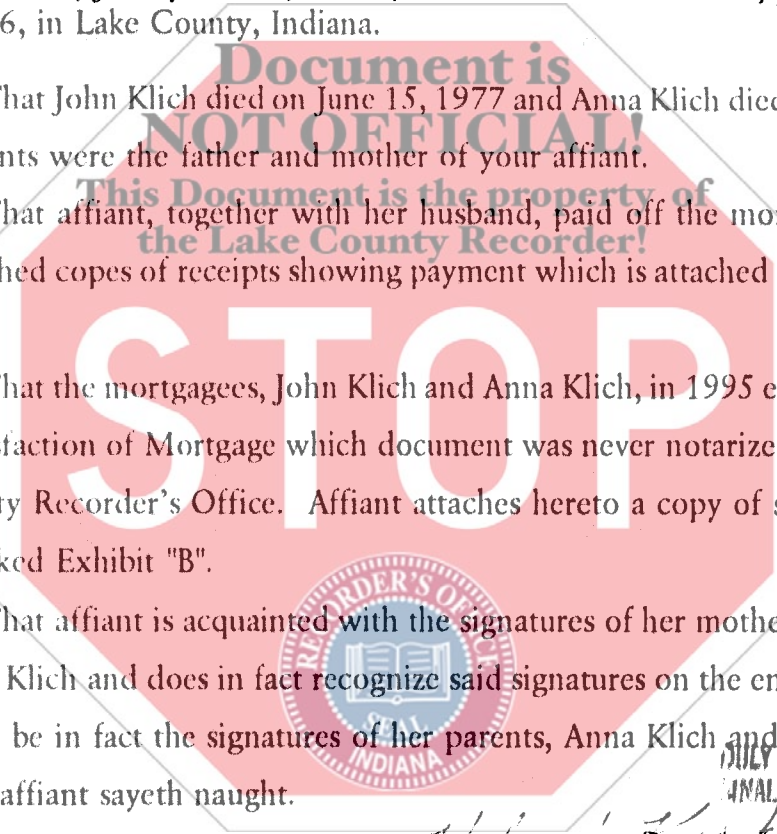
Lot 35, Jeffrey Manor, Unit 2, as shown in Plat Book 38, page 66, in Lake County, Indiana.

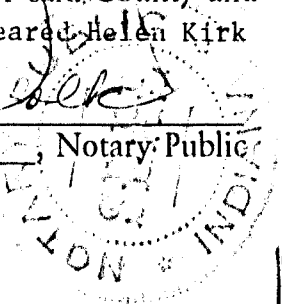
