The undersigned, being duly sworn, depose and say as follows:

1. That she is an adult competent to make this Affidavit;
2. That he is the designated Successor Trustee under a certain Trust Agreement and Deed in Trust establishing the YURGILAS LAND TRUST NO. 1 Walter G. Yurgilas, Grantor
3. That the said Walter G. Yurgilas died on the 25th day of February, 1996;

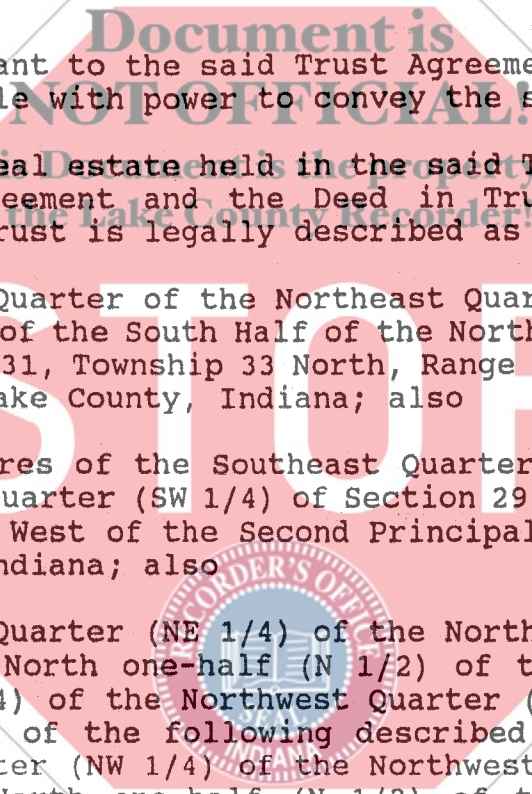


