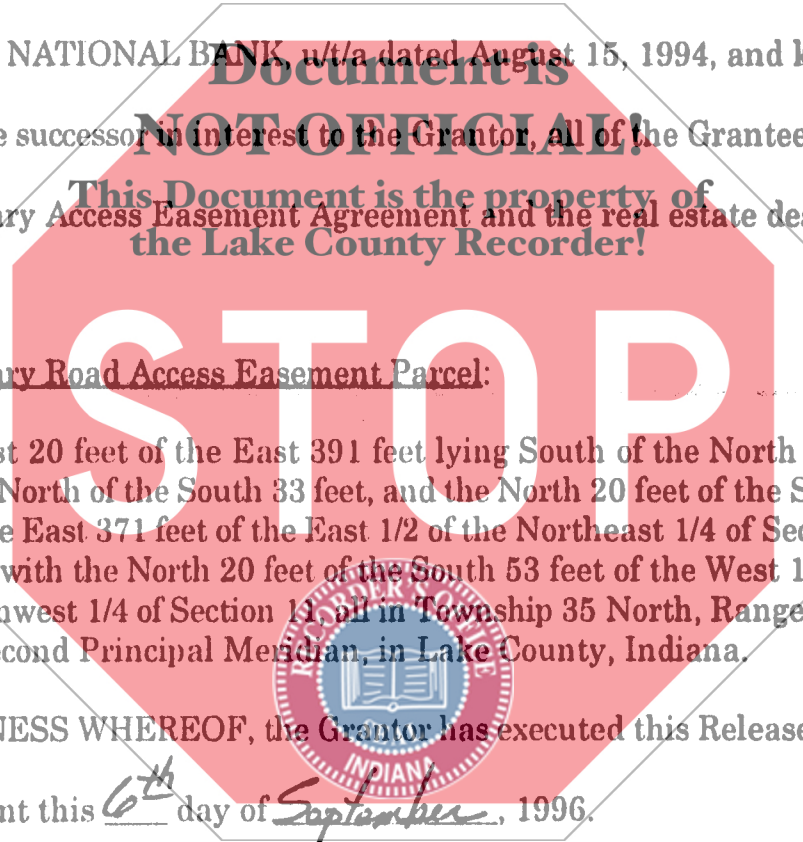
**RELEASE OF TEMPORARY ACCESS EASEMENT**

WHEREAS, on the 25th day of July, 1991, a Temporary Access Easement Agreement was entered into by and between CALUMET NATIONAL BANK, as Trustee u/t/a dated January 3, 1980, and known as Trust P-2596, "Grantor", and GARY HOBART WATER CORPORATION, an Indiana Corporation, "Grantee", and recorded on July 26, 1991, as Document No. 91037574 in Lake County, Indiana, and

WHEREAS, the Temporary Road Access Easement granted therein was never utilized by the Grantee;

NOW THEREFORE, the Grantee, NORTHWEST INDIANA WATER COMPANY f/k/a GARY HOBART WATER CORPORATION does hereby release unto MERCANTILE NATIONAL BANK, u/t/a dated August 15, 1994, and known as Trust No. 5974, as the successor in interest to the Grantor, all of the Grantees rights in and to the Temporary Access Easement Agreement and the real estate described therein as follows:



Temporary Road Access Easement Parcel:

The West 20 feet of the East 391 feet lying South of the North 1314.25 feet and North of the South 33 feet, and the North 20 feet of the South 53 feet of the East 371 feet of the East 1/2 of the Northeast 1/4 of Section 10 together with the North 20 feet of the South 53 feet of the West 14 feet of the Northwest 1/4 of Section 11, all in Township 35 North, Range 8, West of the Second Principal Meridian, in Lake County, Indiana.

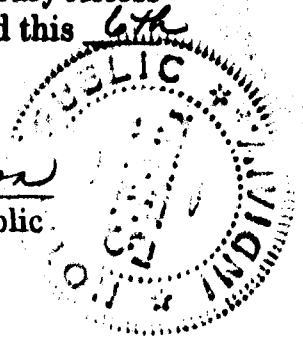
