CONFIRMATORY RESOLUTION NO. 1554

VACATION OF AN ALLEY IN BLOCK ONE (1) LASALLE ADDITION SEP 23 1996

Final Action of the Board

The Board of Public Works of the City of Hammond, Indiana, met to hear remonstrances and take final action on Declaratory Resolution No. 1554 for the vacation of an alley in Block One of LaSalle Addition, to the City of Hammond, Indiana, described as follows:

Commencing at the southeast corner of Lot Twenty-Three (23), Block One (1), LaSalle Addition; thence north to the northeast corner of Lot Twenty-Eight (28), Block One (1), in said Addition; thence east Twenty (20) feet, the same being the width of said alley; thence south along the west line of Lots Seven (7), to Twelve (12), both inclusive, Block One (1) in said Addition to the southwest corner of Lot Twelve (12), thence west to the place of beginning.

The property which will be injuriously or beneficially affected is as follows:

The portion of the alley proposed to be vacated and Lots Seven (7) to Twelve (12), both inclusive and Lots Twenty-Three (23) to Twenty-eight (28) both inclusive in Block One (1), LaSalle Addition to the City of Hammond, Indiana.

There being a verbal remonstrance filed by Frank Betz against the proposed Vacation of Alley in LaSalle Addition, thereupon being fully advised in the matter, Simon with Bell moved that said remonstrance be overruled and the Board takes final action on said Resolution, confirming without modification, all former action on said resolution and the Board now orders that a list or roll be prepared of all owners or holders of property or valuable interests therein sought to be taken or to be injuriously affected which list or roll shall also describe the property beneficially or injuriously affected and futher orders that said portions of said streets and alleys be vacated and revert to the abutting property as stated in said Declaratory Resolution.

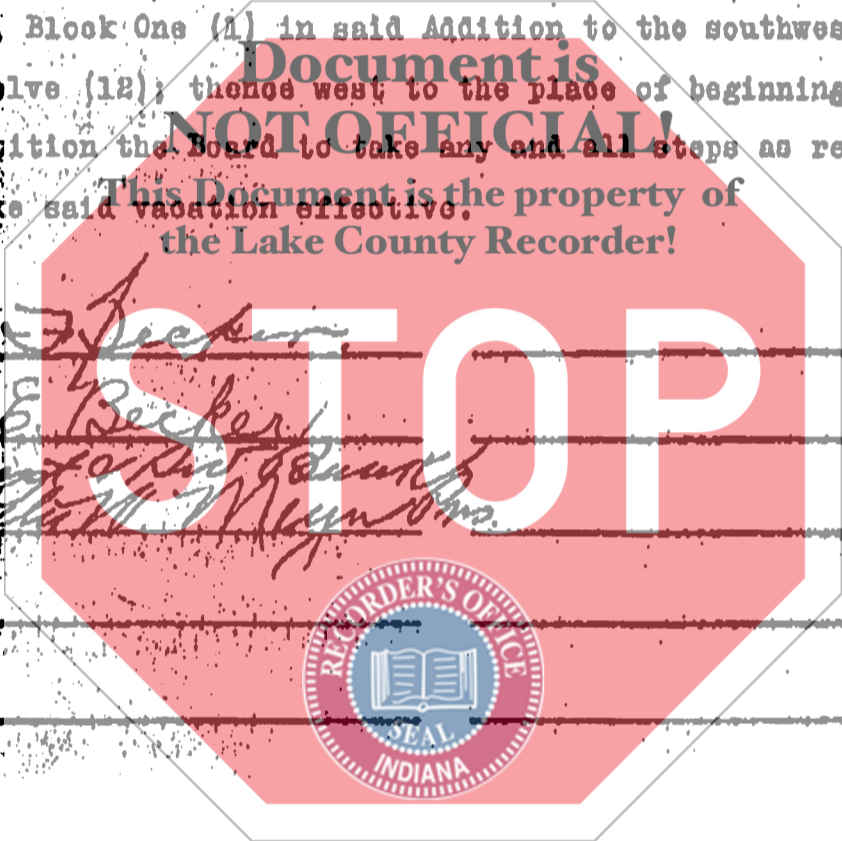
