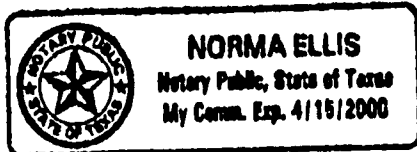

LEGAL DESCRIPTION

Parcel 1: Part of Lot 1, Block 3, in Subdivision of Blocks 2, 3, and 5 and a resubdivision of Lots 28, 29, 30 and 31 in Block 4, Georgia Heights Subdivision, as shown in Plat Book 30, page 48, Lake County, Indiana, described as follows: Beginning at the Southeast corner of said Lot 1; thence North on the East line of said Lot 1 a distance of 16 feet; thence Southwesterly a distance of 80.39 feet to a point on the South line of said Lot 1 which is 79 feet West of the point of beginning; thence East a distance of 79 feet to the point of beginning.

Parcel 2: Lot 2, Block 3, in Subdivision of Blocks 2, 3 and 5, and a resubdivision of Lots 28, 29, 30 and 31 in Block 4, Georgia Heights Subdivision, as shown in Plat Book 30, page 48, Lake County, Indiana; except that part of said Lot 2 described as follows: Beginning at the Northwesterly corner of said Lot 2; thence Southeasterly on the Easterly line of Marcella Road a distance of 16.12 feet; thence Northeasterly a distance of 73.42 feet to a point on the North line of said Lot 2 which is 76.96 feet East of the point of beginning; thence West a distance of 78.96 feet to the point of beginning.
