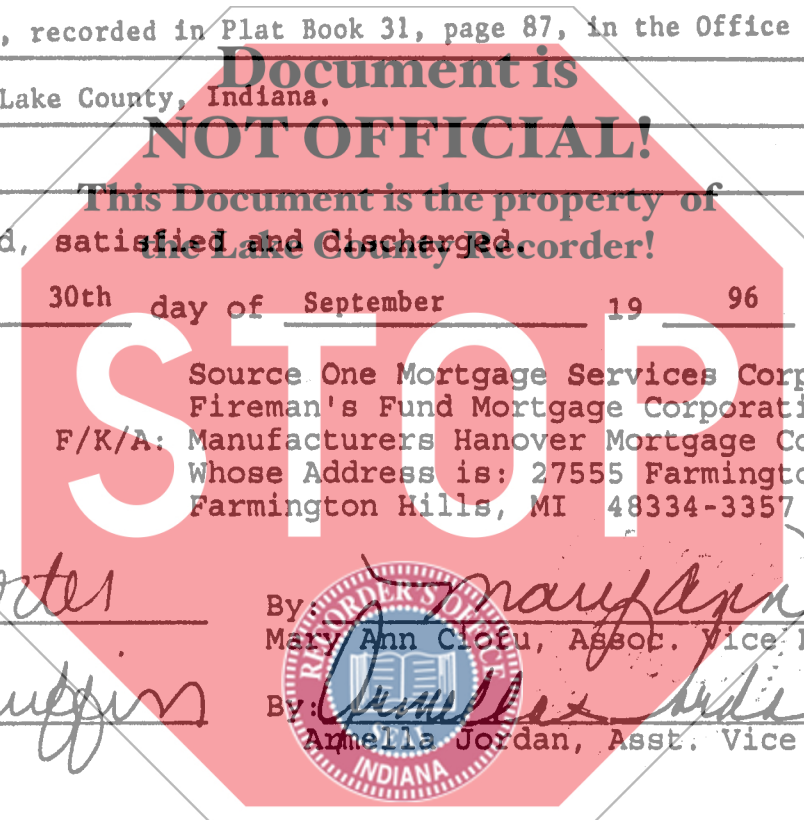


SHORT FORM OF DISCHARGE OF MORTGAGE FOR CORPORATIONS
