

## **CORPORATE WARRANTY DEED**

INDENTURE WITNESSETH that R.M. TEIBEL & ASSOCIATES, INC., a corporation duly organized and existing under the laws of the State of Indiana, located in Lake County, State of Indiana, conveys and warrants to THE TOWN OF SCHERERVILLE DEPARTMENT OF PARKS AND RECREATION of Lake County, State of Indiana, subject to the reservations and exceptions hereinafter made and with the restrictions below stated, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the following described real estate, in the State of Indiana, to-wit:

Being a parcel of land lying in the Northeast Quarter of Section 8, Township 35 North, Range 9 West of the Second Principal Meridian and being more particularly described as follows:

Beginning at the Southwest Corner of Deercreek Park, Unit 1, to the Town of Schererville, as shown in Plat Book 64, Page 35, in the Office of the Recorder of Lake County, Indiana; thence South 89°46'24" West, along the South line of the Northeast Quarter of said Section 8, a distance of 726 feet, thence North 01°23'30" West, a distance of 240 feet; thence North 89° 46'24" east, a distance of 726 feet to a point on the West line of aforesaid Deercreek Park, Unit 1; thence South 01°23'30" East, a distance of 240 feet to the point of beginning, containing 4 agrees more or less.

Provided, that the land hereby conveyed shall be used solely and exclusively for the use and benefit of the party of the second part, and its successors, for the purpose of constructing and operating a Safety Village for public use and education, and that no building or other structure shall be erected on such land that is inconsistent with its use as a Safety Village.
