4. That no application or petition for the appointment of a personal representative is pending or has been granted in any jurisdiction nor is any such petition or application contemplated.

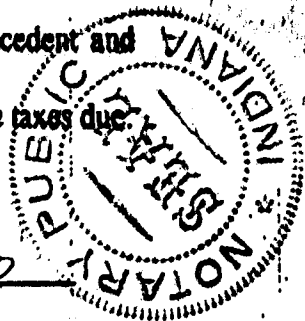
