NOTICE OF LIS PENDENS

1300 Cuth 9415 Dearborn Wholesale Grocers, L.P., by its undersigned attorneys, pursuant to IN ST 34-1-4-1, et seq. files this notice of *lis pendens* in which it states:

- 1. On August 16, 1996 Dearborn Wholesale Grocers, L.P. ("Dearborn") filed suit against Emanuel Torbati, an Illinois citizen ("Torbati") and Interstate Oil, Inc., an Indiana corporation ("Interstate"), and in the Circuit Court of the Nineteenth Judicial Circuit, Lake County, Illinois, Case No. 196 L 606, styled Dearborn Wholesale Grocers, L.P. v. Emanuel Torbati, an Illinois Citizen and Interstate Oil, Inc., an Indiana Corporation.
- 2. In the lawsuit described in paragraph number 1, Dearborn seeks, inter alia, to foreclose on certain financing statements of Torbati and Interstate executed in favor of Dearborn pursuant to which Dearborn became a secured creditor in certain property and fixtures described therein.
