said JOHN STANKOVIC as personal representative of the Last Will and Testament of the decedent, and said personal representative was issued Letters Testamentary on the 1st day of June, 1995, and since that date has continued to serve in such capacity.

3. That the matters and things stated in said accounting and petition are true, and that said personal representative has accounted for all the assets in this estate coming into his hands.

4. 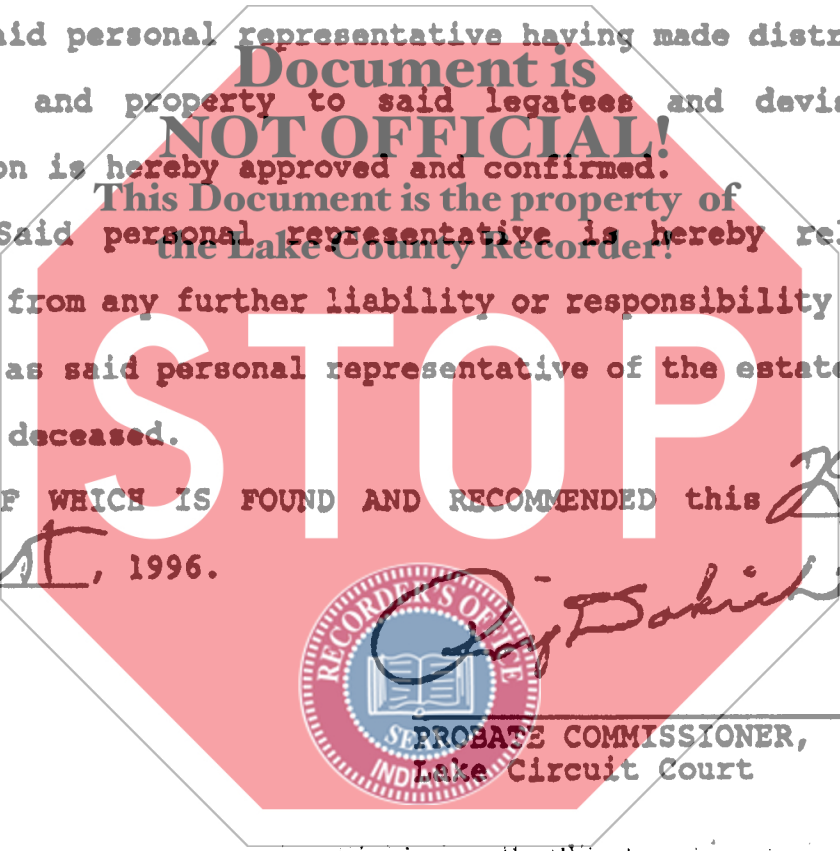
