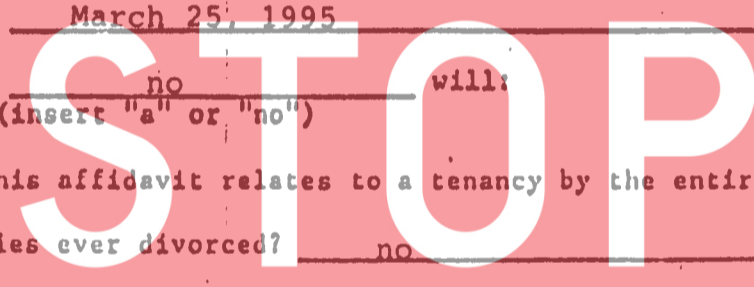

**LEGAL DESCRIPTION**

KEY 17-13-23

A part of the East One-Half (E1/2) of the Southwest One-Quarter (SW1/4) of the Northeast One-Quarter (NE1/4) of the Southeast One-Quarter (SE1/4) of Section Twenty-nine (29), Township Thirty-six (36) North, Range Seven (7) West of the Second Principal Meridian, located in the City of Hobart, Lake County, Indiana, said portion being more particularly described as follows: Beginning at a point on the South line of the East One-Half (E1/2) of the Southwest One-Quarter (SW1/4) of the Northeast One-Quarter (NE1/4) of the Southeast One-Quarter (SE1/4) of said Section Twenty-nine (29), a distance of one hundred fifty-five (155) feet east of the Southwest corner thereof; thence East along the South line of the East One-Half (E1/2) of the Southwest One-Quarter (SW1/4) of the Northeast One-Quarter (NE1/4) of the Southeast One-Quarter (SE1/4) of said Section Twenty-nine (29), a distance of ninety-two and ninety-four hundredths (92.94) feet; thence North and parallel to the West line of the East One-Half (E1/2) of the Southwest One-Quarter (SW1/4) of the Northeast One-Quarter (NE1/4) of the Southeast One-Quarter (SE1/4) of said Section Twenty-nine (29), a distance of one hundred and fifty (150) feet; thence West and parallel to the South line of the East One-Half (E1/2) of the Southwest One-Quarter (SW1/4) of the Northeast One-Quarter (NE1/4) of the Southeast One-Quarter (SE1/4) of said Section Twenty-nine (29), a distance of ninety-two and ninety-four hundredths (92.94) feet; thence South one hundred and fifty (150) feet to the place of beginning.
