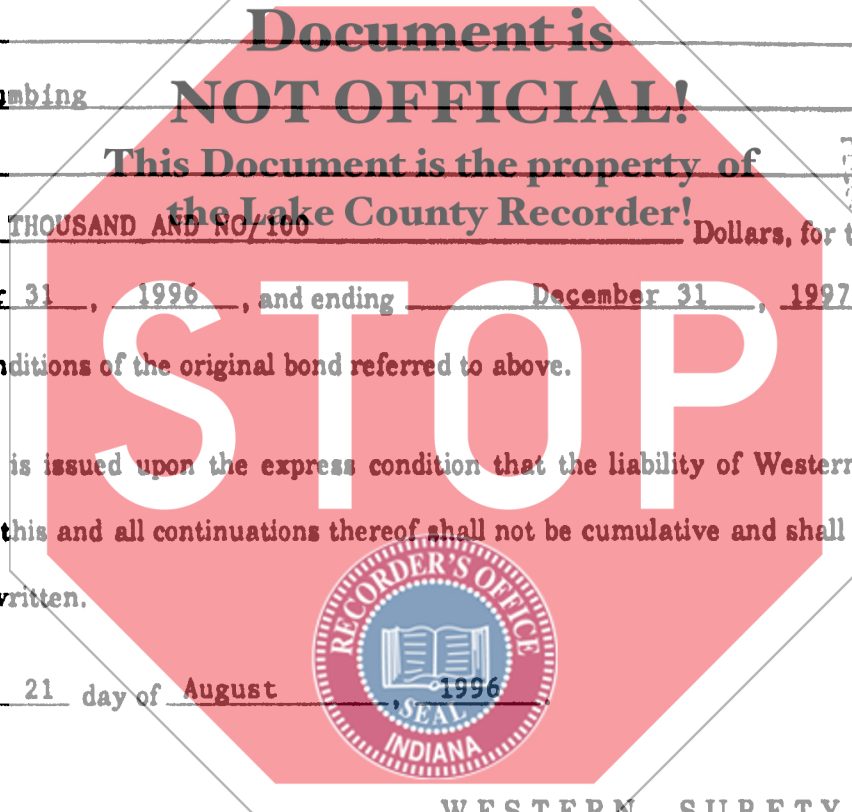

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

Stephen T. Pate of Sioux Falls
State of South Dakota its regularly elected President

as Attorney-in-Fact, with full power and authority hereby conferred upon him to sign, execute, acknowledge and deliver for and on behalf of Western Surety and its agents and deeds, all of the following classes of documents to-wit:

Indemnity Surety and undertakings that may be desired by contract or may be given in any action or proceeding in any court of law or equity; policies indemnifying employers against loss or damage caused by the misconduct of their employees; official, bail, and surety and fidelity bonds; Indemnity in all cases where indemnity may be lawfully given; and with full power and authority to execute consents and warrants to modify or change or extend any bond or document executed for this Company, and to compromise and settle any and all claims of third parties made or existing against said Company.
