Being a part of Lot 7 in the Greens of Scherwood, an addition to the Town of Schererville, as per plat thereof, recorded in plat book 79, page 3, in the Office of the Recorder of Lake County, Indiana:

Commencing at the Northwest corner of Lot 7; thence S 88°43'16" E, along the North line of said Lot 7, a distance of 120.67 feet, to the POINT OF BEGINNING; thence continuing S 88°43'16" E, a distance of 169.40 feet to the Northeast corner of said Lot 7; thence (along the East line for the next three courses) S 43°02'29" W, a distance of 124.80 feet; thence N 89°34'49" W, a distance of 12.00 feet; thence S 50°12'33" W, a distance of 53.21 feet to the most Southeasterly corner of said Lot 7; to a point of intersection with a non-tangent curve, concave Southwesterly, having a radius of 60.00 feet and a central angle of 25°46'39"; thence Northwesterly (along the Southerly line of said Lot 7) along the arc of said curve to the left, a distance of 27.00 feet, said arc subtended by a chord which bears N 52°40'56" W, a distance of 26.77 feet to the point of intersection with a non-tangent line; thence N 31°59'55" E, a distance of 30 feet; thence N 00°05'11" E, a distance of 106.55 feet to the POINT OF BEGINNING.
