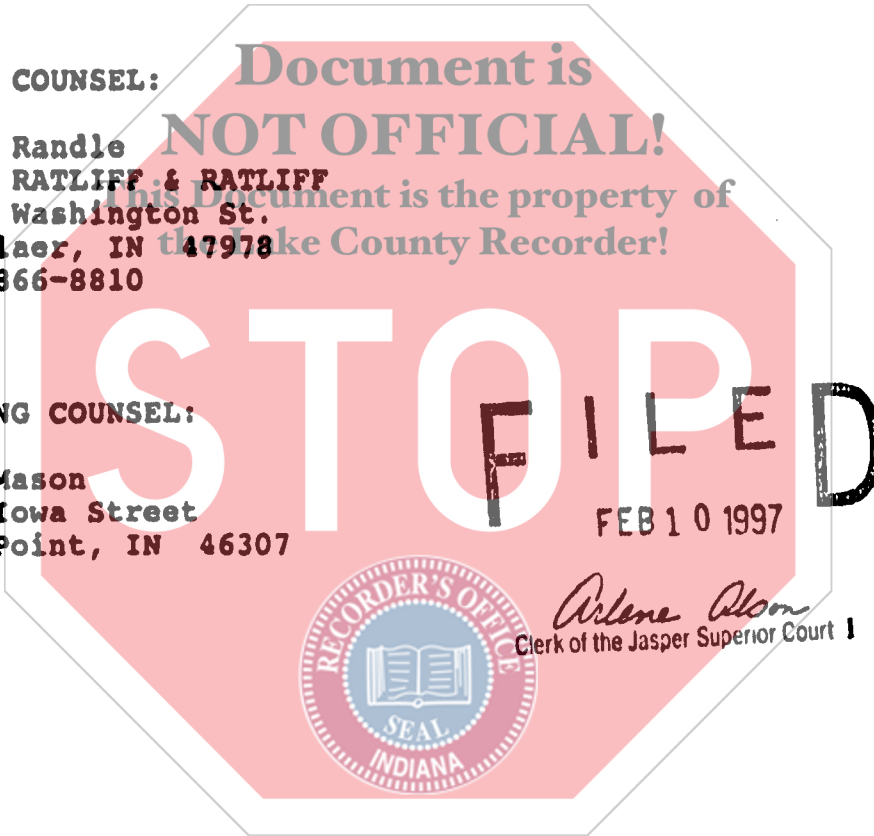

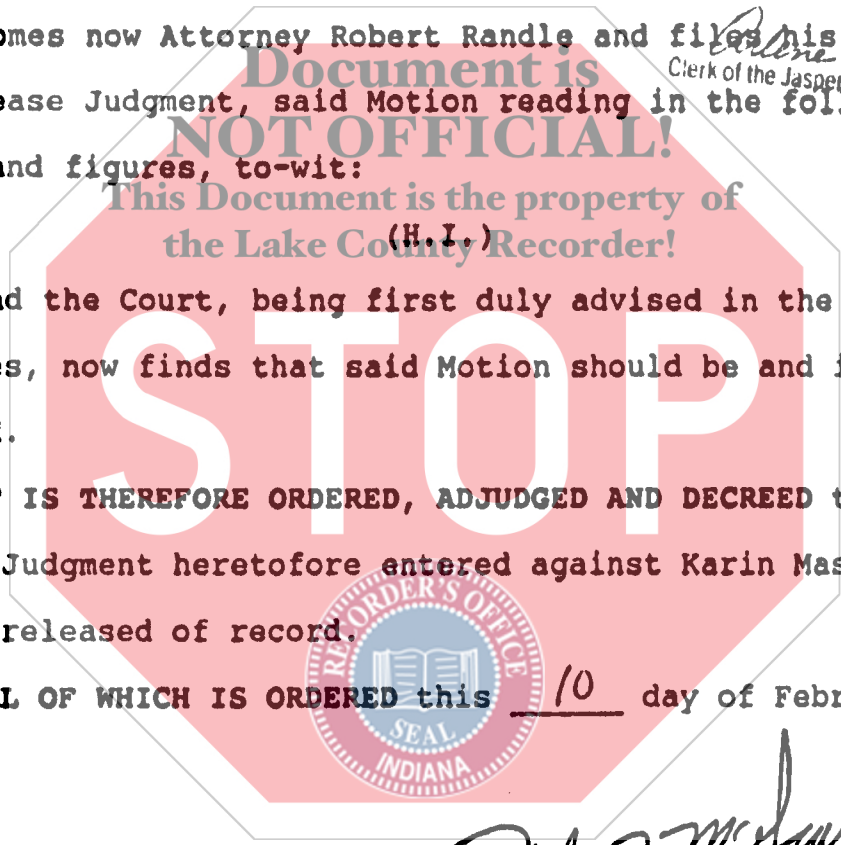

Comes now Attorney Robert Randle and files his Motion to Release Judgment, said Motion reading in the following words and figures, to-wit:

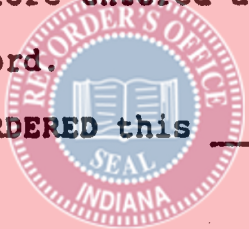
