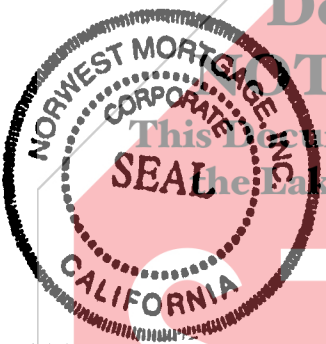
RELEASE OF MORTGAGE

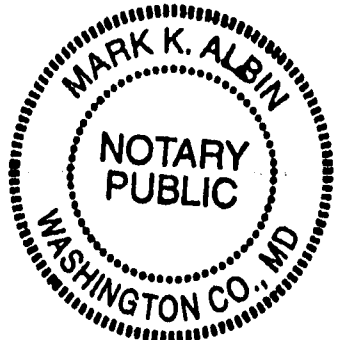
