# MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made and entered into by and between the parties hereto to evidence their execution of a certain Lease dated June 19, 1996 (the "Lease").

#### WITNESSETH:

- 1. The name of the Landlord is the City of Hammond, Department of Redevelopment, whose principal business address is 649 Conkey Street, Hammond, Indiana 46320 ("Landlord").
- 2. The name of the Tenant is Empress Casino Hammond Corporation, whose principal business address is 825 Empress Drive, Hammond, Indiana 46320 ("Tenant").
- 3. The Leased Premises are described on Exhibit A attached hereto and made a part hereof ("Leased Premises").
- 4. The initial term of the Lease ("Initial Term") shall commence on June 19, 1996 (the "Commencement Date") and shall end at 11:59 p.m. Hammond time on the fifth (5th) anniversary of the date on which an owner's license, as defined in IC 4-33-2-15 ("License") that allows the Tenant to own and operate a riverboat casino on Lake Michigan from the City of Hammond, Indiana is issued to the Tenant by the Indiana Gaming Commission.
- 5. The Term of the Lease shall be automatically extended for periods equal to each renewal period of the License granted to the Tenant by the Indiana Gaming Commission; provided, that the total Term shall not exceed seventy-five (75) years.
- The Leased Premises include, but are not limited to, real estate in which Landlord holds an interest as lessee or sublesse under (i) that certain Intergovernmental Lease Agreement and Grant of Easement dated June 19, 1996 between the Hammond Port Authority ("Port Authority"), as lessor, and Landlord, as lessee (the "HPA Parking Lease") a memorandum of which is recorded as Instrument No. in the Office of the Lake County Recorder ("Recorder"), (ii) that certain Intergovernmental Sub-Lease Agreement dated October 13. 1996. as amended as of June 20, 1996 between the Port Authority, as lessor, and Landlord, as lessee (the "HPA Footprint Sublease") a memorandum of which is recorded as Instrument No. in the Office of the Recorder, and (iii) that certain Lease dated June 19, 1996 between the Department of Waterworks of the City of Hammond and the City of Hammond, acting by and through its Department of Waterworks (collectively, "Water Department"), as lessor, and Landlord as lessee (the "Perimeter Road Lease") which is on a memorandum of which is recorded as Instrument No. in the Office of the Recorder. Under and pursuant to the provisions of a certain License Agreement between the Port Authority and Tenant dated June 21, 1996, the Port Authority has agreed that with respect to the HPA Parking Lease and the HPA Footprint Sublease if for any reason the HPA Parking Lease or the HPA Footprint Sublease is terminated by the Port Authority legal proceedings or

otherwise in accordance with the terms thereof, the Port Authority covenants and agrees that such termination of the HPA Parking Lease or the HPA Footprint Sublease shall not result in a termination of the Lease as it pertains to the real estate and interests in real estate subject to the HPA Parking Lease or the HPA Footprint Sublease and that the Lease shall continue in full force and effect as a direct sublease between the Port Authority and Tenant as it pertains to the real estate and interests in real estate subject to the HPA Parking Lease or the HPA Footprint Sublease, so long as Tenant is not in default thereunder for the duration of the term of the Lease and any extensions. Under and pursuant to the provisions of the Perimeter Road Lease, the Water Department has agreed that so long as there is no event of default by Tenant under the Lease, the Water Department shall not disturb Tenant's rights in and to the Leased Premises, and if the Perimeter Road Lease is terminated by the Water Department, the Water Department covenants and agrees that such termination shall not result in a termination of the Lease as it pertains to the leased premises subject to the Perimeter Road Lease, and that the Lease shall continue in full force and effect as a direct sublease between the Water Department and Tenant as it pertains to the leased premises subject to the Perimeter Road Lease, so long as Tenant is not in default thereunder for the duration of the term of the Lease and any extensions thereof.

7. Reference is made to the Lease for the remaining terms and provisions, all of which are incorporated herein by reference.
