**ASSIGNMENT OF LEASEHOLD IMPROVEMENTS**

KNOW ALL BY THESE PRESENTS, that Norwest Bank Indiana, National Association, a national banking association, ("Assignor"), in consideration of the sum of one dollar and other good and valuable consideration, in hand paid by Charles V. Chaffee, Karen J. Chaffee and Clifford W. Chaffee (the "Assignees"), receipt whereof is hereby acknowledged, does hereby sell, assign, transfer, and set over, to Assignees, their successors and assigns, that certain Assignment of Leasehold Improvements, executed by Gary Jet Center, Inc., as Assignor to INB Banking Company, Northeast as Assignee, covering the Fixed Base Operator's Lease dated October 28, 1991, by Gary Airport Authority District and Gary Jet Center, Inc. for property described on the attached Exhibit A, filed for record in the office of the County Recorder of Lake County, State of Indiana, on January 15, 1992, and recorded as Document No. 92002609, said Assignment of Leasehold Improvements was assigned to Assignor by an Assignment dated March 30, 1995, and executed by NBD Bank, N.A., successor in interest to INB Banking Company, Northeast and filed for record in the office of the County Recorder of Lake County, State of Indiana, on April 20, 1995, as Document No. 95021434, together with all right and interest in the property therein described, and in the notes and obligations therein specified, and to the debt thereby secured; and hereby constitutes and appoints Assignees its attorney irrevocable to collect and receive said debt, and to foreclose, enforce, and satisfy the Mortgage the same as it might or could have done were these presents not executed, but at the cost and expense of the Assignees, and does hereby covenant with Assignees, their successors and assigns, that it has good right to sell, assign and transfer the same.

This Assignment is made and accepted with the express understanding and agreement that it is the intention of the Assignor to transfer any and all rights and entitlements it has with respect to the Assignment Leasehold Improvements but that this Assignment is without any recourse to Assignor, and it is accepted by the Assignees with the understanding that no claim may be made by the Assignees against Assignor in connection with this Assignment (other than warranties contained herein), and that the Assignees are familiar with the subject matter of this Assignment and have conducted their own evaluation regarding the value of this Assignment.
