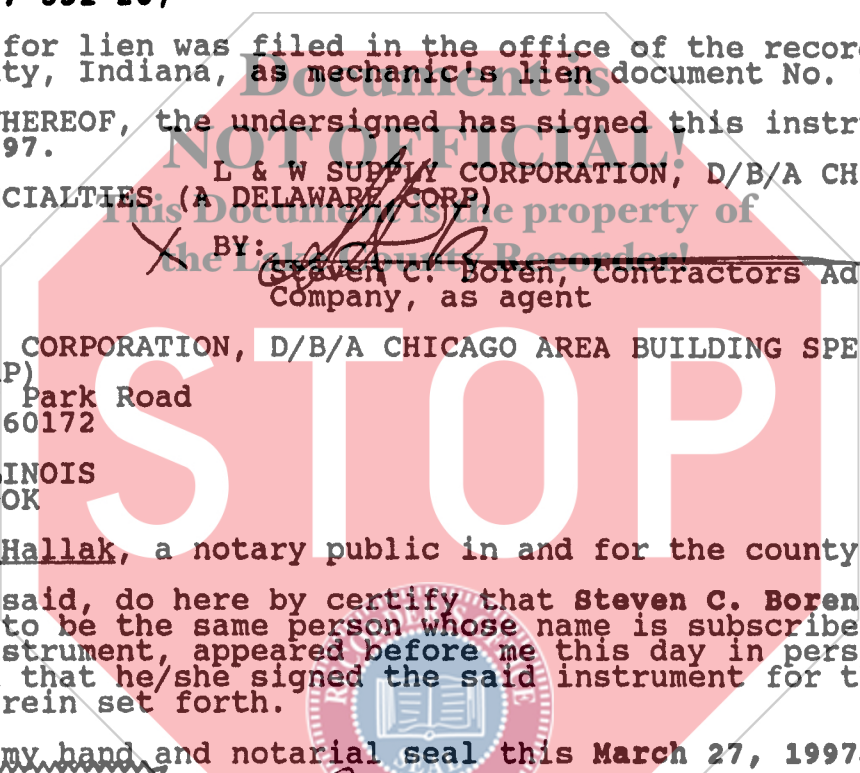

POWER OF ATTORNEY

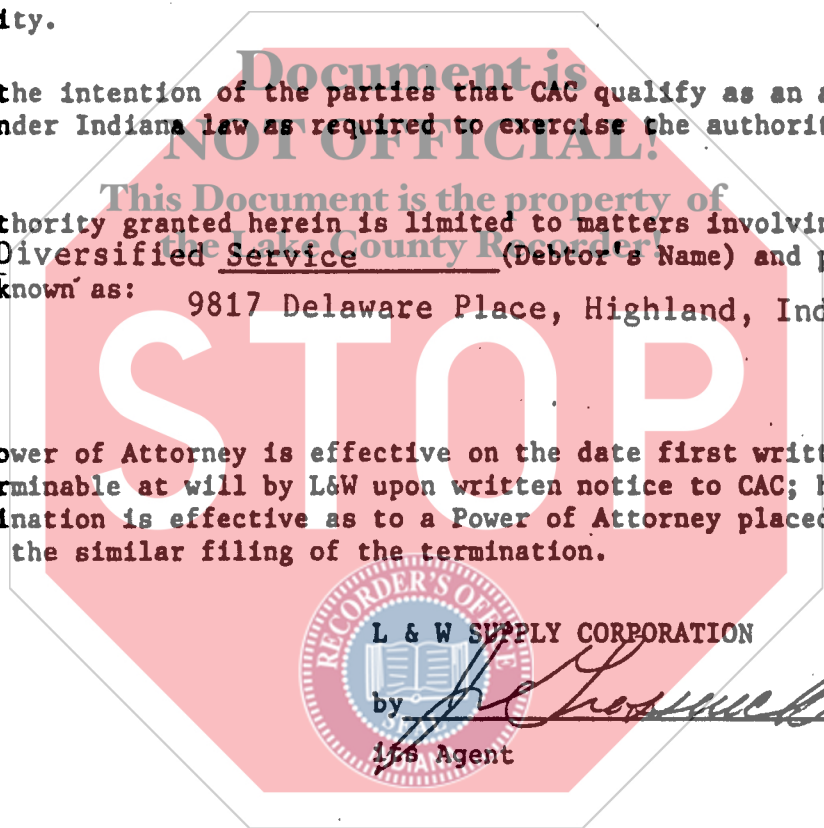
Power of Attorney made this 22nd day of April, 1993.

1.
