AN ORDINANCE VACATING A PLATTED STREET OR PUBLIC WAY WITHIN THE CITY OF HOBART, LAKE COUNTY, INDIANA

WHEREAS, it was presented to the Common Council of the City of Hobart, Lake County, Indiana, Petition No. 96-64, to Vacate a portion of a public street or public way pursuant to Indiana Code, I.C. 36-7-3-12, ct seq., which Petition is in words and figures as follows:

WHEREAS, the Plan Commission of the City of Hobart, Indiana, pursuant to law, held a public hearing upon said Petition to Vacate after giving notice of the Petition and of the time and place of the hearing in the manner prescribed by law and by certified mail to each owner of land that abuts the property proposed to be vacated, and,
