- That the decedent died testate, a resident of Lake County, Indiana, on January 28. 1996; that the decedent's Last Will and Testament was duly admitted to probate before this Court on March 19, 1996, that this Court appointed Roseann K. Kozy and Gloria Gawron as Co-Personal Representatives of decedent's Last Will and Testament and said Co-Personal Representatives were issued Letters Testamentary on March 19, 1996, and since that date have DULY THOUSAND FOR TAXATION SUBJECT TO FINAL AGGLE FAMICE FOR TRANSFER. continued to serve in such capacity.

- 3. That the matters and things stated in said Account and Petition are true and that said Co-Personal Representatives have accounted for all assets in said estate coming into their hands.
- 4. That more than five months have elapsed since the date of first published notice to legatees, devisees and creditors herein. All claims filed against said estate, if any, have been paid or discharged; neither said decedent nor said Co-Personal Representatives were employers of labor as that term is defined in the Indiana Employment Security Act; all estate taxes and inheritance taxes, if any, assessed in said estate have been paid.

That the above described parcels of real estate are the only property remaining for distribution to the legatees and devisees of said decedent.

3. That said Co-Personal Representatives are hereby released and discharged from any further liability or responsibility as Co-Personal Representatives of the Estate of Chester Lacinski and that said estate is hereby closed.
