ASSIGNMENT OF MORTGAGE

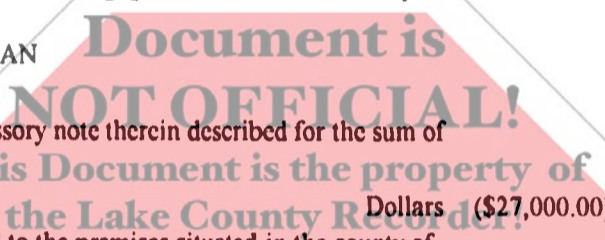
KNOW ALL MEN BY THESE PRESENTS That
