LOAN MODIFICATION AGREEMENT

WHEREAS

**BANK CALUMET, National Association
formerly known as Calumet National Bank**

LOANED

**Robert Ordanas and Beatrice Ordanas,
Husband and Wife**

THE SUM of Sixty Thousand Dollars and 00/100s (\$60,000.00) as evidenced by a note and mortgage executed and delivered on June 7th, 1988, which said mortgage being recorded on June 16th, 1988, in Lake County, Indiana, as document number 982296, and

WHEREAS it is hereby agreed that for and in consideration of Ten and 00/100 Dollars (\$10.00) and other valuable considerations to the lender, the subject mortgage will be modified. After allowing for the April 1st, 1997 payment, the current principal balance will be \$53,546.37. The terms of this modification will be as follows:

1. The new interest rate will be 7.50%, effective April 1st, 1997. The interest rate will change on the first day of April, 2004, and on that date every 12th month thereafter, also referred to as "Change Date". The new rate will be based on the US Treasury Index rate 45 days prior to the change date, plus a variance of 2.50%. The rate will never increase or decrease more than 2.00 percentage points per change. The interest rate will never be greater than 13.50% or less than 7.50%.
2. The new maturity date will be, April 1st, 2027.
3. Monthly principal and interest payments will be \$374.40. The total monthly payment, including escrows, will be \$467.45, beginning with the May 1st, 1997 payment and continuing until at least April 1st, 2004 when the payment will change based on the rate change.

ADDITIONAL payments to principal may be made at any time without penalty and interest will be charged only on the unpaid principal balance.

WHEN THE FULL AMOUNT of principal owing together with interest as above provided, shall have been paid in full, the mortgage lien shall be released. If said amount is not paid in full on or before April 1st, 2027, thence the mortgage may be foreclosed upon for any amount remaining unpaid.

NOTHING HEREIN contained shall be construed to impair the security of the said mortgage nor its successors in interest under said mortgage nor affect nor impair any right or powers which it may have under said note and mortgage for the recovery of the mortgage debt with interest at the rate above provided in case of non-fulfillment of this agreement by said mortgagor.

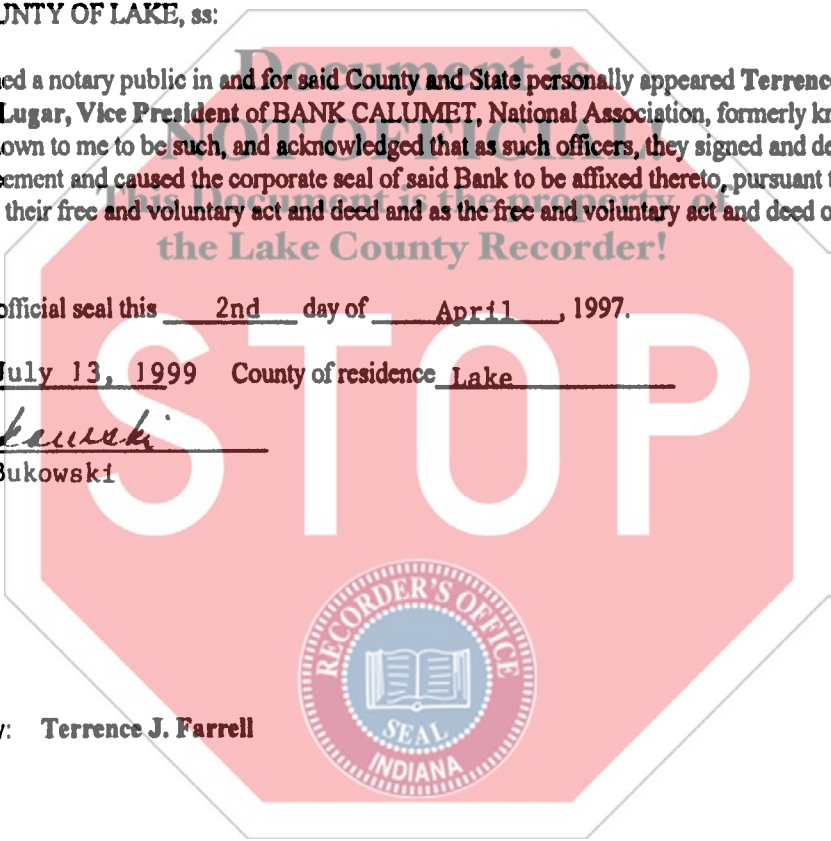
