That she is an adult and the surviving spouse of AARON C. WIREMAN, who died on the 3rd day of March, 1997.

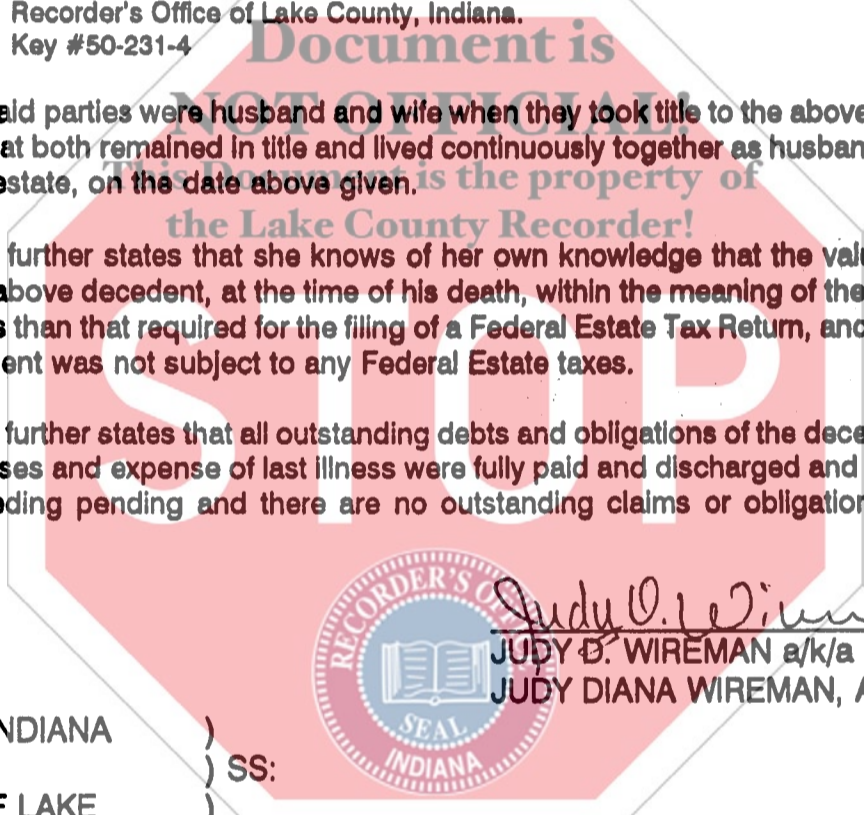
That she and the decedent were owners by the entireties of the following described real estate, to wit:
